#### 6. Architectural Committee- Deed restrictions

All previous violations have been rectified.

New violations of deed restrictions:

A complaint was received by the Board about a Jet Ski trailer, and parked cars in the front yard of 1 Airdrie. A letter was mailed out to the homeowner to notify them that it is a violation of our deed restrictions.

A complaint was received by the Board about a Jet Ski trailer parked in the driveway at 20 Ascot. Verbal communication with the homeowner was made. Homeowner stated it was going to be removed mid-January.

A complaint was received by the Board about, what appears to be an unregistered vehicle at 49 Eaton. A complaint will be filed with New Castle County to verify.

#### 7. Old/New Business

Since we have a homeowner who is 3 years in arrears with their maintenance association dues, Court action will be taken on securing a lien against the property.

On the new web site, we have had some activity on requests for dues being paid. Also, we have received a few homeowners, offering their email addresses to start a list of homeowners. Rich will continue to work on creating an email chain, but it might be a slow process.

It has been observed that a resident seems to be living in her car all day. The car is properly registered and family and neighbors are checking on the resident. No action to be taken.

It was requested that the Board remove a lien on a home that currently owes maintenance dues. The homeowner cannot proceed with re-financing the home, due to the lien. It was decided not to remove the lien, because it would set a negative precedent in the community.
