 As of 10/14, 214 of 215 homes have paid their yearly dues. There is one (1) home delinquent. Steps will be taken to collect the amount per CALFMA policies and procedures.

Grounds & Maintenance Committee Report

The open space areas along Denny Road and Lexington Parkway were cleaned up, mainly trees
and brush. Grading and seeding was done along the tree lines for mowing purposes. The area
needed to be leveled out for future mowing.

Architectural Committee Report

 Solar panels went in on the house along Ascot Court and the final version installed the panels on the roof of the house. This issue was mentioned in the July minutes.

Old Business

- The Board got in touch with a homeowner who was in violation of deed restrictions and had installed a metal gate on their split rail fence. The homeowner has agreed to replace the metal gate with a matching split rail constructed gate in the spring.
- To be fair, the Board did a survey off all split rail fences in backyards and found 22 more violations of this deed restrictions. These violations will be pursued to remedy by an initial notice to be sent out.
- The board has arranged a discounted rate with a local fence supply company for gate purchases to meet and abide by our current deed restrictions. Please contact the board for the supplier information if needed, via the CLFMA primary email address.
- The motion to amend the deed restrictions and allow small vinyl privacy fences along the sides
 of houses is still an open vote. We need 2/3 of the community to vote yes or no to change the
 restrictions. To date, we have 102 yes votes, and we need 143 to pass and allow the change.
 Please respond to communications and queries when you receive them to reach a final
 conclusion.

New Business

- The entrance sign at Lexington/Denny/Airdrie lights went out earlier this mont. An investigation found damaged conductors in a new underground handhole, that was caused during the construction of the traffic circle.
- **Post meeting note**: After much communication and emails to Deldot and Delmarva Power by Rich Boyer, the cable feed was repaired and the lights for night time view of the sign is complete.
