



Emergency Plan for Hurricane - English Milton - 2024

Objective:

Provide a clear and simple guide to help clients and their families stay prepared and safe in the event of a hurricane.

1. Important Personal Information

- Keep an updated list of important phone numbers: your case manager, family members, emergency services, and evacuation centers.
- Ensure your case management team has your up-to-date contact information (phone numbers, addresses, etc.).

2. Family Plan

- **Meet with your family** to discuss how you will stay in contact and where you will go if you need to evacuate.
- Determine a **meeting location** in case you get separated.
- Assign specific roles to each family member in the evacuation plan.

3. Emergency Kit

Prepare an **emergency kit** with the following:

- Drinking water (at least 1 gallon per person, per day, for 3 days).
- Non-perishable food for 3 days.
- Flashlight and extra batteries.
- First aid kit.
- Essential medications (ensure you have enough for at least a week).
- Personal items like clothes, towels, and hygiene products.
- Important documents in a waterproof bag (ID, insurance policies, medication list).
- Portable charger for mobile devices.

4. Medications and Medical Equipment

- Ensure you have enough medication for at least one week.

- If you use medical equipment (oxygen, nebulizers, etc.), check in advance how it will operate or what backup you have in case of power outages.

5. Evacuation

- Keep a list of **accessible evacuation centers** and **shelters**. Inform your case management team if you have specific needs (e.g., limited mobility, transportation, etc.).
- If necessary, coordinate with your social worker to ensure you have appropriate transportation to a shelter.
- **Don't wait until the last minute.** If an evacuation order is issued, follow directions immediately.

6. Communications

- Keep your mobile devices and emergency radios charged to receive weather updates and evacuation orders.
- Consider having an **alternative communication plan** (e.g., texting instead of calling).

7. Additional Considerations

- **Pets:** If you have pets, research in advance shelters that accept animals or how you could evacuate with them.
- **Persons with disabilities:** If you have a health condition or disability, make sure to have a personalized plan that includes additional support.

8. After the Hurricane

- Contact your case manager to report your status.
- Do not return to your home until authorities declare it safe.
- Document any damage to your home or belongings for insurance purposes.

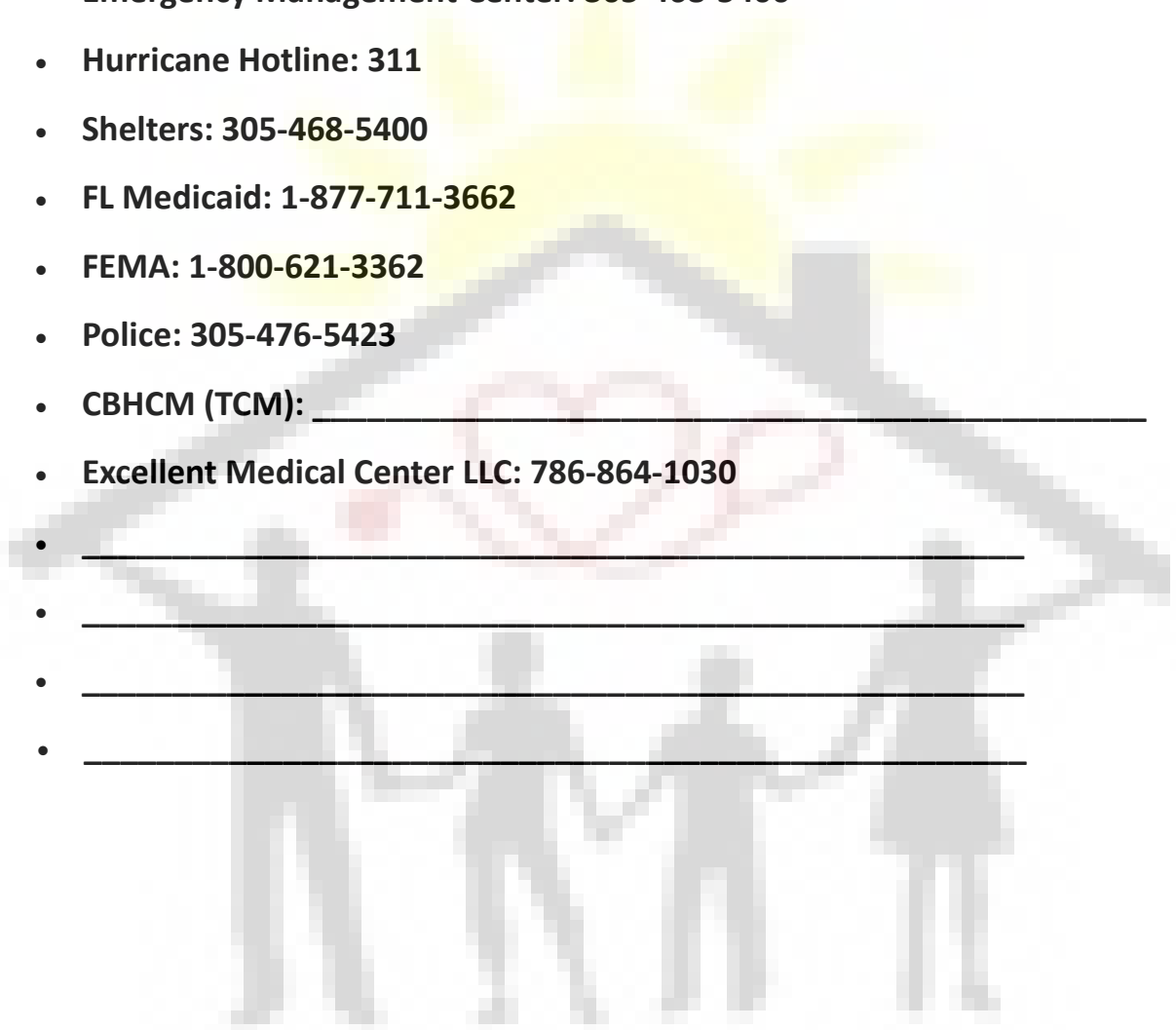
