### **\*The 1999-2004 Port Clinton Walleye Festival Scholarship Fund – March 2006**

Established by the 1999-2004 Port Clinton Walleye Festival to provide one-time, post-secondary scholarships to one or more deserving graduating seniors of Port Clinton High School.

### **\*Ann Bolte Achievement Scholarship Fund – June 2009**
