

# THE DIRTY DOG PET SERVICES, LLC: PET CARE AGREEMENT

1. I understand that THE DIRTY DOG PET SERVICES, LLC (henceforth known as THE DIRTY DOG) has regular hours of operation 6:00am – 6:00pm Monday thru Friday, 9:00am – 6:00pm Saturday, and by appointment only 9:00am – 5:00pm Sunday. Early drop-offs and late pick-ups during week day are available by appointment only starting at 5:00am and 6:01pm, and I will be charged \$3 for each quarter portion of an hour that I am early or late. If I have not picked up my pet(s) by closing time and do not have an appointment scheduled in advance, as detailed above, THE DIRTY DOG will make arrangements for overnight lodging at my expense.
2. I understand that when I bring my pet(s) for lodging, charges begin upon arrival-- regardless of check-in time. I also understand that I will not be charged for lodging on the day of pick-up if my pet(s) checks out before 11:00am that day.
3. I understand that in order to accommodate last minute lodging request during the holidays, THE DIRTY DOG is now requiring a \$40 deposit for holiday lodging, as well as a 72-hour cancellation policy. I understand that if I fail to notify THE DIRTY DOG within the 72-hours of my drop off date, it will result in the forfeiture of my deposit.
4. I understand that there are risks and benefits associated with group socialization. I accept that the benefits of group socialization outweigh the risks. I understand that while group play at THE DIRTY DOG is closely and carefully monitored by the pet-care staff, and although precautionary measures are put into place, it is still possible that minor injuries may occur to my pet(s). If an injury does occur to my pet(s) under THE DIRTY DOG'S care and supervision, I will be notified immediately by a member of the pet-care staff.
5. I understand that THE DIRTY DOG has relied upon my representation that my pet(s) is in good health and has not injured or shown aggressive or threatening behaviors to any people or pets.
6. I understand that THE DIRTY DOG, their owners, staff, partners, and volunteers will not be liable (financially or otherwise) for injuries to my pet(s), or any property of mine, while my pet(s) is participating in services provided by THE DIRTY DOG. I hereby release THE DIRTY DOG of liability of any kind arising from my pet(s) participation in any and all services provided by THE DIRTY DOG.
7. I further understand and agree that any problems with my pet (behavioral, medical, or otherwise) will be treated as deemed best by the staff of THE DIRTY DOG-- at their sole discretion-- in what they view as the best interest of my pet. I understand that I will assume full financial responsibility and all liability for any and all expenses involved.
8. I understand that my pet(s) toe nails may unintentionally cause injury to other pets or people. Toe nails that are too long or too sharp for group play (as determined by THE DIRTY DOG personnel) will be trimmed without question. If THE DIRTY DOG personnel deem my pet(s) nails to be either too long or too sharp, I will agree to pay the fee of a nail trim for \$10.00 plus tax.
9. I understand that by allowing my pet to participate in services offered by THE DIRTY DOG, I hereby agree to allow THE DIRTY DOG to take photographs or use images of my pet(s) (in print form or otherwise) for publication and/or promotion.
10. I understand that I am solely responsible (financially or otherwise) for any harm or damage caused by my pet(s) while attending any and all services provided by THE DIRTY DOG.
11. I understand that reproductively intact pets beyond the age of 5 months will be charged an additional \$10/day special handling fee. I understand that if my pet(s) is reproductively intact beyond the age of 5 months, my pet(s)' group play will be restricted.
12. I understand that THE DIRTY DOG will charge a \$30 fee for all returned checks.
13. I understand that THE DIRTY DOG has the right to refuse services to me and my pet(s) at any time, for any reason, and without prior notice.
14. I understand that if my pet(s) is not picked up by a specified date, I hereby authorize THE DIRTY DOG to take whatever action is deemed necessary for the continued care of my pet(s). I will pay THE DIRTY DOG the cost of any such continued care upon demand by THE DIRTY DOG. I understand that if I do not pick up my pet(s) and do not provide payment in full, or neglect to communicate with THE DIRTY DOG effectively, THE DIRTY DOG will proceed according to the guidelines provided by Kansas State Law Chapter 47-835, abandonment of animals by owner; procedure for handling. I also acknowledge that I will be fully responsible for all attorneys' fees and associated costs if I abandon my pet.
