
# Union of Saints Education & Communication Model



#### 1. Core Principles

Compassion and Respect:

Peace Education: Conflict resolution, mediation techniques, and restorative justice frameworks. Ethical Decision-Making: Balancing societal good with individual freedoms.

Compassionate Engagement:
