

Americans Are Suppressed: Jewish & Activism Cronyism On Facebook

After I posted the reality of the Jewish Sponsored No Kings Protests as well as Black activism against White Americans (evil eye, evil arc) and our hurried work to survive and save our territory, Facebook permanently disabled my account. Since the pandemic, I have been shadow-banned, and blacked out repeatedly. People were unable to search for my name. My posts fell to the bottom of the list. I would review my posts from other profiles I had created to find they were invisible to the public.

We know the truth about the pandemic, they didn't want the truth getting out.

The silencing on this platform left me unable to reach over 4,500 followers. I created a new account and was able to reach others, however the politics of Facebook has become very clear. Their claim is that my account does not meet their "integrity" standards, whereas trafficking, smuggling, and even cannibalism has thrived on their platform. We watched in horror as the world actively genocided the American population on the Facebook platform. It is clear that the truth is suppressed, while hatred and vitriol, as well as conspiracy against Americans is allowed to thrive.

The truth is the truth, and sharing this does not mean I am dishonest, Facebook, the opposite. Suppressing the truth, is where this platform loses its integrity. The “smear-campaigns,” and “blame-shifting,” of the American public has never been so clear.

Anthropological White Americans now just 20% of our country, we had something to say about our freedoms, our rights, and our home. We are losing our people to genocide. *We spoke up.* Wouldn't you?

Our goal is to protect and preserve our country. What is yours? What used to be a friendly college platform, turned into a war zone. Why?

Why was human trafficking allowed to thrive? Why is my voice suppressed? When others are allowed to degrade and attack our military, police and our country-men and women? When men can stalk women with no issues? Why is animal trafficking never questioned?

I see your platform as discriminating against White American women of truth and faith.

Both Dannielle Diamond accounts are suspended.

While I did provide my license, they chose to permanently disable the accounts. I could provide a video recording on the other account, but I am choosing not to. I do not feel safe, comfortable, or able to speak freely on the Facebook platform, and I feel it is highly politicized. There is an experience of political cronyism as well as activist bullying.

I am glad that I had already intended to delete these accounts many years ago and had therefore downloaded my files on several occasions. At this stage, I do not mind being off the platforms, (I mind the force* and voice suppression), as I had intended to focus on my career. However, I am sorry to those I was keeping in touch with via these platforms, as we may lose contact. I did my very best to let others know where to find us. I was hoping that if I were shadowbanned, we would still have another place to communicate.

Americans truly need safe places to communicate freely and to be free from harm. Currently, we do not have enough safety.

Activists shout at others, "Shame, shame!" But in reality, the shame falls on them. They have little accountability for the horrifying societal harms they are causing. They

protest everyone else's problems without realizing that they have become the biggest problem facing society today.

Activists, you are causing too much trouble, violence, and harm to the world around you. Stop the cronyism. Stop the negative activism. The power is with you.

We disabled your account

We reviewed your account and found that it still doesn't follow our Community Standards on account integrity.

You cannot request another review of this decision.
