# Summary of Findings and Public Mercy Cry

To the People of the United States and All Lawmakers Concerned with Justice, Freedom, and Human Dignity:

We, the undersigned, present this summary of findings and urgent call to action, addressing the multitude of crimes, violations, and systemic abuses that threaten the physical, psychological, and spiritual integrity of the American people. Our nation faces unprecedented assaults on individual freedom, bodily autonomy, cultural sovereignty, and public safety.

#### Findings

#### Pornography

The production, distribution, and commercialization of pornography systematically degrade human dignity, exploit vulnerable populations, and corrupt societal norms.

Human and Organ Trafficking

Human trafficking, including forced labor, sexual slavery, and child exploitation, continues at alarming rates.

Organ trafficking and the coercion of individuals for bodily materials represent a grave violation of human rights and must be treated as capital felonies.

### Psychological and Territorial Warfare

Citizens are subjected to organized campaigns of spying, stalking, harassment, intimidation, and other forms of psychological warfare.

Territorial harassment, including unauthorized marches, hoisting of foreign flags, and prayer demonstrations on U.S. soil, undermines American cultural sovereignty and civil peace.

Coercion and Invasion of Autonomy

Citizens are increasingly coerced by government and private entities, including forced medical procedures, mandated medicines or vaccines, and invasion of personal autonomy.

Agencies such as DMVs and health departments have at times acted to threaten, manipulate, or control citizens' rights.

Mass Invasions and Undocumented Settlement Large-scale unlawful migration and mass border crossings threaten national security, public resources, and the safety of citizens.

Unlawful residence by undocumented individuals, when unchecked, undermines the rule of law and societal order.

Biological and Chemical Threats

Actions that meet the definition of biological or chemical warfare, whether intentional or negligent, pose a direct threat to life and liberty.

Lack of Accountability

Many of the perpetrators of these crimes—including traffickers, foreign agents, and complicit officials
—operate with impunity, eroding trust in institutions and the rule of law.

### We urgently call for:

## Immediate Legislative Action

Ban all pornography and criminalize its production, distribution, and sale. Classify human and organ trafficking as capital felonies, with penalties up to and including the death penalty.

Expand the definition of war crimes under federal and state law to include psychological warfare, territorial harassment, stalking, spying, harassment, coercion, mandated medical procedures, and biowarfare.

Protection of Citizens' Autonomy and Cultural Sovereignty
End mass invasions and ensure the mandatory return of undocumented individuals to their countries of origin.

Protect all Americans from coercion, surveillance, and psychological or territorial harassment. Safeguard national symbols, territory, and cultural practices from foreign or domestic interference.

Federal-State Coordination and Oversight
Establish robust task forces and oversight commissions to enforce these laws uniformly across all jurisdictions.

Ensure victim protection, restitution, and rehabilitation for all affected individuals.

Ultimate Accountability

Prosecute all perpetrators, whether individuals, organizations, or officials, to the fullest extent of the law.

Apply the death penalty where crimes constitute war crimes or capital offenses, ensuring justice for victims and deterrence for future perpetrators.

We submit this Mercy Cry not as a partisan plea, but as a call for humanity, justice, and the restoration of order, safety, and dignity in our nation.
