New York City Driver Demographics

In **New York City Uber, Lyft, taxi, and other for-hire drivers**, the available data show a very high foreign-born share.

- **Taxi & for-hire vehicle (FHV) drivers:** about **91% are foreign-born**, according to research using NYC Taxi & Limousine Commission data.
- **TLC's own language-access assessment:** reported approximately **92% of licensed TLC drivers were born outside the United States**.
- **Taxi & limousine service workers overall:** the latest NYC data for **2019–2023** put the foreign-born share at roughly **4 in 5 (about 80%)**.
- A 2020 study sample specifically covering yellow taxis, green taxis, traditional FHV's, and **app-based FHV's such as Uber and Lyft** found **97.2% of its participating drivers were foreign-born**.

Reported Assault Data

30%+ increase 2019, “new normal.”

Both riders and drivers have fallen victim.

61% of survivors were riders.

39% were drivers or third parties/unknown.

43% of the accused parties were riders.

91% of survivors were riders.

~7% were drivers.

81% of survivors were women.

15% were men.

About 4% were of unknown gender.

47% of New York City's population is foreign-born.
