## Arizona and the Slavery Front

The **Sinaloa Cartel**, operating in coordination with networks linked to **CJNG**, has established active operations in Arizona that include child abduction and human trafficking.

This activity represents a **modern slavery and war front within an ongoing transnational conflict**.

These organizations frequently rely on **paid drivers and commercial transporters**, including truckers, to move people and illicit materials across jurisdictions. English proficiency is minimal. Compliance of law are the primary requirements. All factions of this criminal war must be considered when evaluating the scope of the threat.

## Governance, Enforcement, and Consequence

When city or state leaders publicly state opposition to **U.S. Immigration and Customs Enforcement**, while allowing:

- unmanaged homelessness to expand,
- fentanyl distribution to escalate,
- trafficking networks to persist, and
- unlawful entry and presence to remain unaddressed,

these conditions form what can only be described as **New Nation politics**.

These policies do not represent the United States.

They create **real war zones on American streets**, later reframed as political disagreement or policy nuance. The consequences are lived in real time by families and communities. Data confirms what experience reveals. Once the reality becomes visible, it cannot be unseen.

My study of war and slavery led directly to understanding this present crisis and the United States' relationship with what increasingly functions as a **foreign criminal nation operating within our borders**. The reality is frightening. May the missing child referenced here find her way home.

# Why Enforcement Matters

**“This is why we support ICE. Period.**

The following individuals were real Americans who should still be alive today.

Each was killed in a separate violent crime committed by a person unlawfully present in the country.

Different states. Different dates.

**The same pattern. The same failure of enforcement.**

- **Dacara Thompson (19)** — Killed in her home in Bowie, Maryland; her body was discarded from a bridge.
- **Laken Riley (22)** — Attacked while jogging on campus; beaten, suffocated, and assaulted.
- **Rachel Morin (37)** — A mother of five abducted on a hiking trail, killed, and concealed in a culvert.
- **Kayla Hamilton (20)** — A young woman with autism, bound, assaulted, and strangled in her home.
- **Jocelyn Nungaray (12)** — Abducted, assaulted, and killed in Houston; found in a creek.
- **Larisha Sharell Thompson (40)** — Shot and killed during a random attempted robbery in South Carolina.
- **Jamiel Shaw II (17)** — A high school athlete shot in the street after being mistaken for a rival gang member.”

These families deserved protection. These lives deserved safety. These tragedies were preventable.
