

Foreign War and Harm Against the American People — Request to Return University Positions to Qualified Americans – Domestic Separations

In light of concerns regarding foreign war, foreign influence, and actions that may have caused harm to the American people, I am requesting a comprehensive review of university positions and opportunities. Where positions have been improperly allocated to foreign professors, or Americans have been unlawfully harmed by hate speech or hateful actions, those positions should be restored to qualified American applicants and educators.
