

# A Statement on Safety, Sovereignty, and Freedom

## A Unified Testimony by D. Cowdrey

After extensive case research and direct exposure to severe social and institutional failures, I made a conscious political decision. I chose the stance of the Republican Party. I will not vote for the Democratic Party again, not unless I can trust that **White Women's** rights are also protected.

→ ***Both parties harm women, promote violence, genocide and slavery.***

This decision followed sustained study of exploitation patterns, trafficking, environmental harm, public health failures, and systemic gaps in protection. The conclusions reached through data, case review, and lived experience were devastating.

Young American women are among the most frequently targeted populations for exploitation and violence, while receiving minimal representation and protection. Outcomes consistently fail to align with public rhetoric promising universal safety. Once these patterns become visible, they cannot be unseen.

The experience of becoming a minority in one's own country is deeply disorienting and painful. This nation is home. It is the only home many Americans have. Other nations prioritize protection of their people, culture, and sovereignty as a matter of survival. Americans are increasingly pressured to surrender these same protections in the name of global accommodation, even when the cost includes safety, freedom, health, and life.

This erosion occurred through policy choices, institutional pressure, and the weakening of enforceable boundaries. What is described abstractly as politics is experienced in daily life as insecurity, vulnerability, and loss. Communities absorb the impact first. Women bear disproportionate risk. Families carry lasting consequences.

Voices are diminished. Concerns are sidelined.

She deserves better.

Advocacy for her safety remains limited. Warnings are minimized. Repeated violence is reframed or dismissed. Suffering is frequently politicized rather than addressed. In many circumstances, the most visible protection comes from those in uniform, while they themselves are also attacked. Institutions debate whether prioritizing her safety is appropriate, she will have few places to turn.

I stand as both a victim of these failures and a witness to their consequences. This is my testimony:

**Young American women deserve protection, representation, and truth.**

# The Missing Voice: Moderate, Anti-Slavery Voters

There is an absence of political representation for moderate, anti-slavery Americans. Many voters are guided by foundational principles rather than ideology or extremism.

These principles include:

- Personal and public safety

- Freedom from all modern forms of slavery

Modern slavery includes:
