Educational Reflection and Assessment Document

Purpose:

This document provides a structured framework to identify, assess, and reflect upon potential anti-White racism or bias in social, institutional, cultural, and interpersonal contexts. It is intended for educational, policy, and community use.

Language and Expression Indicators

- Generalizations or stereotypes applied to White people as a group
- Derogatory jokes or insults targeting White identity
- Dismissal of concerns solely because the individual is White
- Framing Whiteness as inherently immoral rather than behavior-based critique

Double Standards

- Hostility tolerated when directed at Whites but condemned elsewhere
- Emotional harm minimized due to racial identity
- Unequal application of respect standards

Institutional and Policy Indicators

- Policies that penalize individuals based on White identity
