Conversational Etiquette, Accountability, and the Union of Saints

Recalibration, as understood by the Union, is an ongoing process, returning ourselves, our communities, and our world to balance through reflection, responsibility, and ethical action.

Educational and Pastoral Scope

Our educational position includes:

- National security awareness and risk mitigation
- Thoughtful engagement with issues of war and peace
- Civic responsibility and lawful conduct
- Education grounded in discernment and ethical reasoning

Alongside this, we share pastoral reflections that are personal, intimate, and honest, offered with integrity and care. We also contribute our spirit through creativity, art, devotion, and service to both our church body and the greater good.

Understanding Disruptive or “Class Clown” Behavior

Disruptive behaviors, particularly those that disregard conversational etiquette, learning objectives, or communal boundaries, are understood as misaligned energy that pulls a group below its intended arc of growth. Such behaviors often distract from learning, diminish collective focus, and fail those entrusted with teaching, mentoring, or ministering.

The goal of the Union of Saints is to remain above the arc, not below it. This means fostering:

- Freedom of thought
- Respect for intuition and conscience
- A soulful, innocent, loving, kind, and compassionate posture

At the same time, we practice patience, forgiveness, understanding, and restorative learning, without excusing repeated disruption or disregard for shared standards.

Positive Patterns and Communal Discernment

Through consistent practice, the Union cultivates positive patterns, shared understandings, and what may be described as “silent languages”—unspoken norms grounded in respect, responsibility, and care. These allow members to discern alignment with the Union’s values.

With time, it becomes clearer who is actively participating in the Union’s shared commitments and who remains, for now, outside this structure as a civilian participant or observer. This distinction is not a judgment, but an acknowledgment of differing stages of readiness, understanding, and engagement.

Growth, Structure, and Future Orientation

As the Union continues to mature, we remain devoted to organizing our structure and recalibrating our methods so that lessons are increasingly accessible to broader cultures and communities. Until then, we proceed with the cadence established through years of learning, service, and reflection.

By this stage, many years into our collective work, we recognize that we have entered a third chapter of development. Within this chapter, members understand themselves as Aspiring Santas or Santas, Sisters, and Brothers, united in shared responsibility, devotion, and purpose.
