

Journal - Pesticide Re-Exposure Arizona

Today, I am waking up with severe reproductive pain from the pesticide exposure. It was only applied outside. This is how permeable this stuff is. They know exactly what their products do, yet they keep spraying.

It kills aquatic life and fish. That's our reproductive system. I know, we aren't ready to hear that yet, but we are born in fluid, and within our bodies we are water system beings. These pesticides can be absorbed through the skin and enter the body. With PermaSease, permethrin, my pain was really neck, forehead, nerve, heart, and thyroid related. However, with fipronil, or Termidor, my pain has been severe reproductive pain. This pain endures no matter how much I "shower."

I had just moved into a beautiful new apartment and had heavily invested in brand new belongings before I was sprayed the last time. A nightmare. This was my first exposure, and I had to spend hours discovering what had happened.

Because I was so determined to get these pesticides out of my living environment, I moved across the country and donated all of my belongings that I believed were covered in pesticides, even my brand new mattress and clothes. This time? I thought I was safe. So, I chose to make my second investment.

I spent six months recovering my home and investing in it again. Next thing I know, a man is in my backyard. I locked my doors because I was afraid he might be an intruder. He left and then came back with a canister.

I opened the door just to let him know that I was allergic to pesticides. I was taken by surprise. It had been months since I had been exposed. This couldn't be the same stuff? All the way in Arizona?

He was spraying outside.

Boom.

The perimeter of the apartment was sprayed. Next thing I know, the entire apartment was fumigated once again. All of the symptoms I had worked so hard to get away from, and was still recovering from, including thyroid pain, returned.

This time? It brought another evil friend.

Severe and debilitating reproductive pain. It's left me in tears. To be honest as I can be, it feels like "rape by technology," except, this is a different kind of technology, it's a volatile chemical. It is chemical warfare on my ability to have a baby.

I consider this a complete loss. I have already notified them that I will be moving, and my things are packed. Yet now I am afraid of my own belongings because of the exposure. I can't imagine having to do this all over again, just to donate what I invested in.

Thankfully, I do have insurance, so I will file a claim. I will contact a lawyer. I have now experienced injury and pain following pesticide exposures that I never consented to, and in fact, I feel that I was told through words and actions, and through the suppression of my voice, that I had no autonomy. Same idea, different weapon.

Imagine.

After my experience, I no longer believe this is just about "terminating bugs." I feel that we are losing our safety and well being. The truth is, we are losing our people and our ability to have babies to pesticides. Like forced vaccines, forced pesticides must be investigated, documented, studied, and taken seriously.

I know we aren't ready to hear this yet.

But we are living through a genocide by pesticides.
