Example DMV Follow-Up Correspondence

Dear Concord DMV,

I am writing to follow up regarding my vehicle registration, which I initially requested to be updated in February and was reportedly lost in the mail. Since that time, I have made multiple attempts to resolve this matter but have not yet received my registration.

Additionally, I previously submitted a record change request to remove myself from the organ donor list. This request was returned with a note regarding out-of-state addresses for military

personnel. To clarify, I did not request an out-of-state designation. I provided both my physical address and a separate mailing address, and my request was solely to withdraw my consent to be listed as an organ donor.

I would like to formally request the following:

1. An update on the status of my registration and confirmation of when I can expect to receive it.
2. Correction of my record to ensure I am no longer listed as an organ donor.
3. Confirmation that my address information is properly recorded, including both my physical and mailing addresses.

I also want to note that my previous experiences at the Concord DMV have been challenging, including extended wait times, denial of submitted documentation, and difficulty resolving discrepancies in my records. I am hopeful that this matter can now be addressed efficiently and accurately.

For reference, I am legally recognized under the names Dannielle --- (birth name) and Dannielle --(changed name), and my records may appear under either.

Please confirm receipt of this email and advise on the next steps to resolve these issues.
