

“Decolonize” Movement, Modern Warfarists Against the American People and the West

Dear Representatives,

I am writing because the United States needs to take the growing “decolonize” movement seriously. The movement is promoting racial hostility, political violence, foreign influence, organized crime, and destabilization within the United States. The American people deserve to understand what is happening inside their communities and whether foreign or organized interests are exploiting political divisions.

Think about the word being used. “Decolonize” means to remove a colony, and this raises serious questions for our public safety about who is being removed and who is expected to replace them. When political movements describe an entire population as colonial, oppressive, or illegitimate because of their ancestry, Americans should pay attention because this is a war front.

There are individuals within these movements who openly describe America and Western civilization as colonial systems. Some direct anger toward people based upon race, ancestry, nationality, or perceived connections to European history. Modern Americans cannot be held personally responsible for events that occurred centuries ago, and historical grievances do not justify targeting innocent Americans today.

Political rhetoric encouraging hatred, intimidation, violence, or removal of another population creates a serious threat to American communities. Modern warfare does not always look like a traditional battlefield, but it is still warfare. Fourth generation warfare involves propaganda, psychological operations, information warfare, political infiltration, economic pressure, cyber activity, organized crime, manipulation of migration, and exploitation of divisions within our population.

Acadians know this history all too well. The Acadian people experienced displacement, confiscation, forced migration, separation of families, and destruction of established communities. History demonstrates what can happen when powerful political forces decide that an established population can simply be removed, replaced, or treated as an obstacle.

The decolonize political movements are encouraging Americans to view their fellow citizens through the lens of race and historical grievance. America is a nation of generations of immigration, migration, intermarriage, and cultural blending. Many Americans have ancestry crossing multiple populations and historical periods, making collective racial blame especially dangerous and destructive.

Organizations involved in these movements receive substantial public or private funding while promoting political movements that contribute to social division and instability. Nonprofit finances should be transparent and comply with federal and state law. It is not acceptable for decolonize movements to garnish wages from the same taxpayers that they seek to “decolonize.”

This is warfare, this is slavery, and this is exploitation. Political movements should not divide populations while benefiting from the financial systems and public resources of the country they seek

to “decolonize.” Representatives should follow the money and determine who is funding these organizations, who is receiving the money, and where those funds are going.

Foreign actors are exploiting American political movements and social divisions. Foreign governments, criminal organizations, extremist networks, and other hostile interests use money, propaganda, migration networks, online activity, political organizations, and other channels to influence Americans. These activities require investigation and oversight.

Foreign military aged men are entering the United States through migration channels and becoming involved in organized criminal networks, extremist movements, foreign influence operations, and other activities directed against Americans. These are credible threats that require serious attention from our government. Our government has a responsibility to identify these threats before Americans are harmed.

If someone comes to America and becomes involved in criminal activity, hold that individual accountable. If a foreign national commits a serious crime, enforce the law, and if a foreign government directs unlawful activity inside the United States, investigate it. If American citizens are involved in unlawful activity, they should be held accountable as well, because the same law should apply to everyone.

I am asking my representatives to investigate individuals and organizations associated with the “decolonize” movement for racial intimidation or violence, threats against Americans, organized criminal activity, foreign funding, foreign direction, and foreign influence operations. Our representatives should also examine connections to political violence, attacks against military personnel or law enforcement, immigration exploitation, human trafficking, financial fraud, nonprofit fraud, cyber activity, propaganda, and psychological operations.

Our public servants, military personnel, law enforcement officers, intelligence professionals, and homeland security personnel deserve particular protection. These individuals are trained to recognize patterns of criminal activity, threats, infiltration, organized operations, and foreign influence that ordinary citizens may never notice. They should have the resources necessary to identify these threats and report suspicious activity.

America should never punish people simply because of their race, ancestry, nationality, religion, or political beliefs. Political ideology cannot become a shield for criminal conduct or foreign interference. Credible threats associated with the decolonize movement must be investigated regardless of where its leaders are from or who is responsible.

We need facts, investigations, transparency, and accountability. We need to understand who is funding these movements, who is organizing them, who is directing them, and whether foreign interests are exploiting domestic divisions. Most importantly, we need to know whether Americans are being deliberately targeted because of their race, ancestry, political beliefs, military service, occupation, or membership in a particular community.

We are facing a severe national security emergency in which organized groups and foreign actors are attempting to harm Americans and destabilize the United States. The American people should not have

to wait until violence occurs before government officials take credible warnings seriously. Prevention, intelligence gathering, lawful investigation, and oversight are essential to protecting our country.

I am asking you to support oversight and appropriate investigations into foreign influence, organized criminal activity, political violence, nonprofit financial activity, immigration exploitation, cyber activity, and other unlawful conduct connected to these movements. I am also asking my representatives to examine whether federal agencies have the resources and authority necessary to identify emerging forms of domestic and foreign influence. The American people deserve transparency, and there is no place in the United States for “professional” and strategic race wars such as those being promoted through the decolonize movement.

Protect the American people. Protect our communities, our public servants, our military, our law enforcement officers, and our government. Protect the United States from anyone who seeks to use our own divisions against us.

The line should be drawn at the race war that is the decolonize movement. It should be drawn at criminal conduct, violence, foreign interference, and attacks against the American people. Political disagreement is part of America, but Americans should never be targeted through intimidation, violence, organized crime, or foreign operations.
