Lawyers from *anywhere* may join and are currently promoted, as they have actively recruited the “international community” to fight the U.S. and U.S. interests.

Same story, different organization: “abolitionists” piggyback on “race conflict” to incite violence against White Americans, seek to close prisons and mass-release prisoners, oppose any form of border, border patrol, ICE, and DHS measures, act as a front against national security, safety, and the protection of Americans, and radically support foreign interests.

Operates like any radical faction, such as Antifa, promoting terrorism via an “activism vehicle.”

NLG lawyers may practice anywhere in the world.

Delegations include Cuba, Haiti, Palestine, Honduras, Venezuela, Korea, the Philippines, Mexico, and others. “Does not discriminate based on nationality.”

Thousands of members are not attorneys at all, despite it being a “lawyers guild.”

NLG has an Iran “subcommittee” on “Iranian liberation.”

NLG engages with “communist and revolutionary movements,” including internationalism such as the “People’s Republic of China.”

National Immigration Project of the NLG is a separate organization, and its funding is considerably larger. Its 2024 filings, for example, list grants from **Rockefeller Philanthropy Advisors (\$775K)**, **Neo Philanthropy (\$740K)**, **Together Rising (\$230K)**, **Ford Foundation (\$230K)**, **Heising-Simons Foundation (\$200K)**, and others.

We view this as a fourth-generational war front against the American people that is actively subverting Americans and suppressing the truth about modern war, terrorism, transnational repression, the Cold War, and organized crime.

Unfortunately, the same patterns and trends can be seen throughout these branches of activism-terrorism. They have, and will continue to, severely harm the U.S., our defense, and our citizens.

We consider this a breach of U.S. law systems, acts of terrorism, treason, and warfare. The U.S. is being targeted by an “international regime” that is a “Trojan horse,” pretending to be a “left party,” and has altered, via mass negative propaganda campaigns, the worldview of the Democratic Party.

They are posing a serious danger to the American people and, unfortunately, have shaped this into a modern genocide and Holocaust. The patterns were clear across the board.
