

NO STALKING · NO HARASSMENT · NO COLD-WARFARE ORDER

Notice of Non-Tolerance for Psychological, Reputational, or Strategic Harm

Purpose

This document serves as a formal notice and standing order establishing clear boundaries against stalking, harassment, psychological warfare, reputational harm, and other coordinated or strategic behaviors intended to destabilize, dehumanize, or injure individuals or communities.

Such conduct is not tolerated, regardless of whether it is framed as humor, commentary, concern, entertainment, ideology, activism, social pressure, or “war tactics.”

Scope of Prohibited Conduct

The following behaviors are expressly prohibited when directed toward us, our members, affiliates, or protected persons:

1. Stalking and Surveillance

Including but not limited to:

- Monitoring, tracking, or observing activities without consent
- Repeated unwanted contact or attention
- Use of third parties, digital tools, or social channels to surveil

2. Harassment

Including:

- Repeated unwanted communications
- Intimidation, coercion, or pressure
- Attempts to provoke reaction or distress
- Persistent boundary violations after notice

3. Defamation and False Allegations

Including:

- Knowingly false statements presented as fact
- Mischaracterization of lawful or ethical conduct
- Accusations of criminal, immoral, or prohibited behavior without evidence
- Spreading rumors, insinuations, or distortions

4. Incrimination and Entrapment Tactics

Including:

- Attempting to provoke or fabricate wrongdoing
- Framing normal behavior as suspicious or illegal
- Selective or bad-faith reporting
- Manipulative setups designed to create false records

5. Discrimination and Dehumanization

Including: - Targeting individuals based on identity, autonomy, belief, or independence - Infantilization, pathologizing, or portraying a person as unstable or dangerous without basis - Language or narratives that strip dignity, agency, or humanity

6. Psychological or Cold-War-Style Tactics

Including but not limited to: - Smear campaigns - Gaslighting or reality distortion - DARVO patterns (deny, attack, reverse victim and offender) - Social triangulation or mobbing - Strategic silence combined with narrative manipulation

These tactics are recognized forms of harm, not discourse.

7. Framing Harm as Entertainment or Comedy

Harm does not become acceptable when labeled as: - “Just joking” - Satire - Commentary - Performance - War bits

Intent does not override impact.

Standing Boundary and Order

Effective immediately: - All such conduct must cease. - No further contact, commentary, surveillance, or narrative construction is permitted without explicit consent. - Any concerns must be specific, factual, evidence-based, and submitted through appropriate lawful channels, not informally, socially, or publicly.

Notice of Consequences

Continued engagement in prohibited conduct may result in: - Documentation for record and file - Formal complaints - Cease and desist actions - Mediation or legal escalation - Protective or restraining measures where applicable

Silence or non-engagement by us does not constitute consent.

Non-Retaliation Clause

This order is preventative and protective, not retaliatory.

It exists to preserve safety, dignity, and lawful conduct.

Affirmation

We affirm: - The right to personal autonomy - The right to reputation and dignity - The right to exist without harassment, psychological warfare, or strategic harm

Cold war tactics, reputational warfare, and dehumanization strategies are not tolerated by us.

Effective Date

This notice is effective upon issuance and remains in force indefinitely unless revoked in writing.

Jurisdictional & Legal Standing Language

Jurisdiction

This Notice and Order is issued under the principles of applicable local, state, and federal laws governing harassment, stalking, defamation, coercion, intimidation, and civil harm, including but not limited to laws related to: - Harassment and stalking - Defamation and false statements of fact - Coercive or intimidating conduct - Civil conspiracy and coordinated harm - Intentional infliction of emotional distress - Interference with lawful activity, reputation, or livelihood

Jurisdiction shall be proper in any venue where the conduct occurs, where its effects are felt, or where the protected individual or entity resides or conducts lawful activity.

Applicability Across Mediums

This Order applies without limitation to conduct occurring through: - In-person interactions - Written correspondence - Telephone or voice communications - Electronic communications (email, text, messaging apps) - Social media, digital platforms, or online forums - Use of intermediaries, third parties, or proxy actors

Indirect action is treated as direct action for purposes of enforcement.

Notice and Knowledge

This document constitutes formal notice.

Once notice is given: - Continued conduct may be deemed knowing and willful - Claims of ignorance, humor, misunderstanding, or informal intent do not negate responsibility - Repetition after notice establishes pattern and persistence

No Waiver of Rights

Nothing in this Order shall be construed as a waiver of any rights, remedies, or protections available under law or equity.

All rights are expressly reserved.

Good Faith and Lawful Conduct Clause

This Order does not prohibit: - Lawful speech - Good-faith reporting supported by verifiable evidence - Legitimate legal processes conducted through proper authorities

It does prohibit the misuse of such processes or speech as tools of harassment, intimidation, or reputational harm.

Severability

If any provision of this Order is found unenforceable, the remaining provisions shall remain in full force and effect.

Continuing Effect

This Order shall remain effective indefinitely and shall apply to ongoing, repeated, or renewed conduct, regardless of time lapse or changes in method, platform, or participants.

Governing Law

This Order shall be interpreted in accordance with the laws of the applicable jurisdiction(s) in which enforcement or remedy is sought.
