Additional references are cited in the individual P&Ps.

**Prevailing Statute:** Should these Policies & Procedures or any Arbor Lakes governing documents lag behind Florida statutory changes, the new statute takes precedent.

**Severability:** Should any portion of these Policies & Procedures be deemed invalid by competent legal authority, all other provisions here-in shall remain in full force.

**Grandfather Clause:** Decisions under prior policies remain currently valid, provided they are lawful. **Scrivener's Errors:** Scrivener's errors and updated statute references may be corrected without formal amendment.
