


- Browse to https://app.certify.me/CoorsEventServices
- On the first screen, enter your text number or an email address, then click the Get Verification Code button. A verification code will be sent to the number/address you enter on this page.






 On the next screen, enter the verification code you receive in the space provided and click Next:

Coors Field Screening Survey

Signs are in place and sanitizer stations are available around the Ballpark to help you remember and follow the State's recommended health and safety guidelines during this time. Please answer the questions below

Temperature Reading - Do you currently have a fever equal to or higher than 100.4° F?

Have you tested positive for COVID-19 in the last 14 days?

Have you been in close contact with anyone who has tested positive for COVID-19 in the last 14 days?

Definition of close contact is someone who was within 6 feet of an infected person for a cumulative total of 15 minutes or more over a 24-hour period starting from 2 days before illness onset (or, for asymptomatic patients, 2 days prior to test specimen collection) until the time the patient is isolated.

You have completed your Coors Field Touchless Registration. Your QR Code is below and has also been sent to you




 When you arrive at Coors Field, you will see a Certify station. Display the QR Code you obtained in the previous step to the Certify computer. It should recognize the code almost immediately. If you hear a buzz when you present your QR Code, you have presented an invalid QR Code and must re-take the survey to obtain a valid QR Code:





- Once your QR Code is accepted, stand in front of the Certify computer and it will take your temperature:
- If you have a normal temperature, you will see it in green and you will hear a ding. You have been authorized to access Coors Field, enjoy your shift. If you have a high temperature, it will display in RED, and you will hear a buzz. Please exit Coors Field and contact your supervisor immediately.







If you did not complete the survey or did not receive the link, there will be an opportunity to access the survey at the employee entrance. For those who do not have the ability to access the survey there will be a paper survey available for you to complete at the employee entrance.
