## FORM A - ABUSE AND DRUG POLICY

The undersigned person submits the following information for the purpose of inducing the Boys abd Girls Club of Van Buren (BGCVB) to employ the undersigned or permit the undersigned to act as a volunteer worker for BGCVB

- 1. The undersigned represents and warrants that all of the information contained herein is true, correct and complete, and that if any of such information becomes incorrect or incomplete after the date hereof, the undersigned will immediately notify the CEO of BGCVB of such change.
- 2.The undersigned has attached hereto, a copy of the undersigned's current driver's license (both sides) and social security card. The undersigned authorizes BGCVB to conduct investigations of, make inquiries about, take statements from, and obtain reports from, private individuals and governmental entities, which information relates to any of the matters set forth in this application, and to use and release to third parties the applicant's personal information on this form in furtherance of the investigations and inquiries set forth herein. Additionally, the undersigned agrees to execute such other documents as BGCVB may request, authorizing state and/or federal entities to release information to BGCVB concerning any of the matters set forth herein.

**Boys and Girls Club of Van Buren** is committed to selecting and retaining effective staff and volunteers to serve our youth. As part of the selection process and in accordance with state background check regulations, background checks and screening procedures are conducted in accordance with this policy.

## BACKGROUND CHECKS

Boys and Girls Club of Van Buren conducts criminal background checks of all employees, including minors; board volunteers and others who serve on a standing committee; and all other volunteers, including partners and minors, who have direct repetitive contact with minors.

Name-based or fingerprint-based record searches may be used in any combination, but the background check shall at a minimum:

- background check shall at a minimum:
   Verify the person's identity and legal aliases through verification of a social security number.
- Provide a national Sex Offender Registry search.
- Provide a comprehensive criminal search that includes a national search.
- Provide a comprehensive local criminal search that includes either a statewide or county level criminal search, depending on jurisdiction (a current list of jurisdictions can be found at www.bgca.net/childsafety).
- Include any additional background check criteria required by organizational policies, funding or licensing agencies or required in the applicable jurisdiction, such as motor vehicle records, child abuse registry or credit checks. Such checks will be conducted prior to employment and at regular intervals not to exceed twelve months.

All background check findings shall be considered when making employment or volunteer decisions, and Boys and Girls Club of Van Buren will not employ potential staff or engage potential volunteers if such individual:

- a. Refuses to consent to a criminal background check.
- b. Makes a false statement in connection with such criminal background check.
- c. Is registered, or is required to be registered, on a state or national sex offender registry.
- d. Has been convicted of a felony consisting of:
  - 1. Murder
  - 2. Child abuse
  - 3. Domestic violence
  - 4. Abduction or human trafficking
  - 5. A crime involving rape or sexual assault
  - 6. Arson
  - 7. Weapons
  - 8. Physical assault or battery
  - 9. Drug possession, use or distribution in the last five years
- e. Has been convicted of any misdemeanor or felony against children, including child pornography
