Ryan Thomas Hock v. Wisconsin DHHS

Regarding Amended Complaint Ordered to be completed and submitted by November 4th.

In the same time frame as when I was ordered to complete the updated complaint form listing all defendants in one document with description of individual guilts; I was made utterly unable to do said task by law enforcement warrantlessly harassing me with attempted illegal arrest and who also intimidated my Boss (Sammy's Taste of Chicago in West Allis WI) into firing me and the same intimidation cost me my housing plans which would have been equity investment instead of rent that must be purchased back from me at the time kicked out or moved.

My Lyme disease medication needed to handle life's worst hurdles and daily successful functioning was not available in emergency situations (as you are aware I was facing imminent eviction for the failure of my roommate to pay any rent) and was replaced with neurotoxic red 40 containing Dexedrine that was so not having useful for productivity effects (maybe they designed it for recreational use and addiction as those pills cause a withdrawal and form of confusion as well as aggression and irritability). The added poison causes excitotoxicity which is suspicious to add to an ADD med because excitotoxicity causes mental cloudiness looking like ADD. It is clinically treated with benzodiazapines and then hypothetically on the street with opioids.

Stimulant users are the least likely to use opioids (Dexedrine is an amazing painkiller as well as ADD med), and simultaneously the most likely to be medically informed (able to recognize the red 40 as causative and research the published treatment). I am needing as medically necessary the Mallinkrott brand Dexedrine free of harmful additives etc that I have had great benefits from for around a decade of responsible use.

I managed to recognize the symptoms early but still had to use it to manage to move my property and try to get housing (unsuccessfully). I got some efficacy from extraction of the real Dexedrine from the poison additives using water dissolution and centrifugation to separate the layers. I wasted large quantities of pills that way and the pharmacy won't let me return the remaining pills for replacement with Mallinkrott brand Dexedrine free of harmful additives.

I managed to get a real Non-psych doctor to prescribe my dextroamphetamine sulfate without adding the string of harmful substances like Antipsychotics by injection. This is appropriate because I have verified medical conditions: Lyme Disease (brain fog and joint pain Dexedrine treats both effectively)/ADD/Chronic Fatigue syndrome (Lyme induced but made worse by Antipsychotics).

I also take the Dexedrine for independent functioning & earned income such as employment. It has been indispensable for competent informed voting: which was impaired significantly during the timeframe of the accusations of election-fraud.

The fact is that I was impaired at every time I should have been able to work on this case. I am now living day to day without guarantee of housing and having to move often and still expected to pay rent. I have spent too much time on unproductive and without success actions to get housing.

The DHHS failed to renew my food stamps using the argument that I had to tell them where I worked. Well when they found out on their own they sent police without warrant or department authorization to intimidate my boss into firing me and to follow me home after I picked up my last paycheck where they demanded illegal entry and even grabbed/assaulted a Tenant trying to force entry (We called and asked the West Allis police department and contacted media and the FBI when it was clear that they were not acting as officers of the law protected by their adherence to their oath of office).

If the requested injunctive relief against the Wisconsin DHHS and associated (ex. Includes requiring that actual law breaking occurred before police powers are able to be used in a violent and/or coercive manner_no more ch 51 enforcement) is applied towards everyone then I can't make the court wait for me to complete a task that I might indefinitely be impaired from completing. In that case just go ahead and use the original complaint.

The only value (financial compensation) to my naming all the guilty I know of and can get evidence against is the tort claims for assault and battery that are important to deter future actions of deprivations of rights under color of law.

Even though money is needed for survival primarily from ch 51 induced externalities and intentional malpractice direct effects, I guess I won't manage to maximize the payout while being deprived of money even enough to survive and under harassment.

Injunctive relief is the only part that matters now. Sure the idea of getting real justice and financial compensation for damages sounds good but isn't possible to pursue while the damages continue to add up.
