

Hello,

I am very distrustful of the victims compensation program that requires the repayment of "crime related expenses" which seems to include committing Obstruction of Justice and deprivations of rights under color of law and outright entrapment and illegal activities (such as payments for "mental health" bullshit bill of attainder Treasons and the fake crack cocaine left on my table after retailatory breaking and entering for reporting a slave pen lock that I removed and destroyed (see pictures). The guard of the extortionist landlords called me a "crackhead" in response to my questioning the obvious break in.

For the record if I was a crack cocaine user the work requirements of the judicial system due process that is ever culmulative under deprivations of rights under color of law would be much more manageable.

I submitted samples of the fake crack cocaine to the Federal Government along with other evidence including the possibility that the current landlord murdered the real house owner and has been operating under his business name. (Unopened mail addressed to real business owner along with cell phone left in closet along with personal affects not usually discarded). I also found a baggie on the street in 53202 with similar not cocaine substance indicating a widespread violation of truth in advertising and 4th. I have read of similar illegal distribution of fake cocaine in the city of Waukesha that was actually the poison anabuse. I suspect the DHHS and associated unconstitutional prevailing powers.

My bank account was fraudulently charged for my balance by someone pretending to be U-Haul (wrong amount and exactly my balance).

I am being utterly coerced into applying for the victims compensation program that as written is very corrupt and horrifying. I'm being sentenced to homelessness on the 3rd of February by the extortionist landlords who seem to be slave traffickers (see pictures)

Violations of FCC regulations against biologically active emf at amplitudes that dampen the central nervous system used widely to induce drug dependencies and homelessness etc. Along with violation of Article 1 section 9 and 10 Bills of attainder such as ch 51 WI statutes Antipsychotics to force drug dependency on pain of DEATH (4th/18th/21st) (13th/8th) (14th) (15th/19th/24th/26th) all violated grossly via bills of attainder including ch 51 WI statutes and all similar unconstitutional so called laws and fake courts not even open to the public. All of them voided qualified immunity by not adherence to the constitution and those so called Judges are not honorable at all. Titles of nobility given to psychiatrists such as "the meaning of the facts". Fuck that to hell.

I only managed to survive this long by refusing to comply with the Baal worship of Antipsychotics (throwing up all doses I could wrapped my tongue in plastic for the saphris etc). They injected me with abilify, haldol and zyprexa and lobotized me. I'm utterly drug dependent

now to survive and deprived of real medicine such as my dextroamphetamine sulfate free of harmful additives etc to be unable to even apply for benefits like this in a timely manner to expect any real help to happen. I already needed the dextroamphetamine sulfate free of harmful additives etc for twice infected with Lyme disease and they tortured me simply for having success in recovery.

The three black cats are obviously not the landlord's who tried to order me to call a shelter to have them taken to be routed to high school anatomy dissection. Two are siblings (Sapphire Female and Diamond Male) and one is older (Little Buddy Male). They were terrified of them and hiding under his bathtub refusing to come out. Indicates violent removal of at least two families. They are currently under my care and sentenced to death when I become homeless. I would like them reunited with their families. They are very friendly towards me and seem grateful for non fluoridated/not poisoned water but I'm struggling to give them basic necessities due to the deprivations of my dextroamphetamine sulfate free of harmful additives (it's the truth I'm not even capable of taking care of myself anymore because of this). I have repeatedly been given poisoned knockoff versions such as Aurobindo and KVK Dexedrine instead of the real Mallinkrott brand Dexedrine free of harmful additives etc violations of truth in advertising and 4th/18th/21st. The people who subjected me to the bill of attainder ch 51 WI statutes (my parents) continually tell me to abandon my cats and that I am somehow irresponsible for not being a cruel and horrible person. Every single time I got a job after ch 51 the police have been used to execute more bill of attainder ch 51 to prevent me from earning money even at a low paying job.

Others with decent intent continually try to tell me to call 911 and the police but don't understand that under Ch 51 that is suicide. I tried to buy a phone with removable battery and not induction powered so as to be able to call 911 if only for the sake of others but AT&T in 53202 told me it was in a time delay safe even after I showed pictures of the slave pen lock. I knew that to mean only illegal arrest so I fled after calling them out on their bullshit. This resulted in a horrifying retaliation by the police and ambulances of 53202 who left to the poorer parts of town including 53212 where I heard numerous gunshots that were standardized probably shotgun and without return fire. They couldn't have gotten any form of judicial branch approval or review and had to have already known where they planned to go.

Sapphire was the most difficult to get out from under the bathtub and I eventually found her hiding in the wood frame of a mattress in the room next to the bathroom, very terrified and unwilling to be handled; and she is adorable and comes up to me and suckles on my tie and has eyes similar to my deceased Annie Hock feline (often round pupils very rare for a cat).

Diamond is friendly and affectionate towards me and my cats often grooming them.

Little Buddy gets jealous of Hygieia Hock and does mad dashes to get out my door when I leave (after seeing me allow Hygieia to come outside of my room with me). He also likes to play with water. He seems very afraid of being abandoned and has attempted many things to be

affectionate towards me. He can be clumsy and it's kind of hard not to laugh when he jumps onto the desk but falls short.

10+ missing persons last mailing address here. See pictures. USPS refused to pick up return to sender anymore and at least one returned to sender more than once. Some family of current USA legislator Ortiz.

My two cats (Free Ya Hock {I'm renaming her from Freya who the original owner gave her but didn't want to keep or care for her and she is a very well behaved person} and Hygieia Hock (My baby girl who loves to play with water and go on adventures always jumping on my back when I leave my room, see also makes little antennas out of aluminum foil so I call her my radio technician). They are victims of my inability to provide for their basic needs due to deprivations of rights under color of law and I'm desperate to save them from a horrible date. I didn't maim them and want them to develop naturally without spaying or declawing or anything otherwise unethical). I'm crying now.

Also the issue of the dissolved animal body (evidenced by microscopy showing pathogens of the gastrointestinal tract and my missing hydrochloric acid {I redacted a following statement regarding the legal use I have for that acid}) and the associated dissolving of my ceiling is yet to be a closed case.

My best friend of over 10 years Annie Hock was murdered by illegal pesticides sprayed for months by Ron Becker 477 w. Main street Waukesha WI 53216. He reportedly owns many properties in the area and is a known slumlord who reportedly favors sex offenders (for some form of "intergovernmental resources funding" giving them his better housing units. Mentioned because of the DHHS policy of forcing us into poverty and prescribing date rape drugs by force such as Seroquel Zyprexa invega haldol abilify etc. Questioning this resulted in punishment injections of antipsychotics instead of being allowed to defraud Medicare by picking up the date rape pills and stockpiling them for thieving landlords like Ron Becker who used one day evictions to steal property massively). Those date rape drugs are not permitted to be sold on the street for obvious reasons of the ethical difference between the people illegally incarcerated and those promoted as psychiatrists. Think about it for real. These are plainly observations and facts.

Ron Becker sprayed those poisons that are for agricultural use only and even then requiring a permit in a manner that would never solve the bedbug problem (room by room) you are supposed to evacuate the building, tent it and wait for days to weeks to reinhabit the building. He was intentionally causing illnesses and despite my and others injections and warnings. The them property manager reported to me that he even offered to pay for tenting the building himself. My room didn't suffer bedbugs I had a cat named Annie Hock who dutifully patrolled my room and looked me up and down as I slept. She developed breast cancer from the pesticides and died despite two chain mastectomies. She really didn't deserve that fate. The

only times I found bedbugs in my room was directly after other people had been inside and only a few found even then. The infestations were massive in other rooms.

Ron Becker might have been motivated to get approval to do illegal human experimentation using a fungus sourced from an American university. He tried to leverage my Biochemistry degree and Biology degree to get support for this but I refused to support the obvious respiratory illness causing fungus he ended up using anyways causing at least one Man and his daughter to cough up blood and flee for their lives. Fungus reproduce by spores so even if a somewhat harmless soil fungus in the environment is a biological weapon in a residence when in high concentration. It also survives by killing animals duh dumbasses. I explained this to Ron Becker, he simply wanted a "yesman" not a real scientist.

It is possible that he lied and pretended to have some form of military clearance to perform these atrocities as per another incident in which a couple of tenants quickly left claiming pain from a double knee replacement (she had a double knee replacement obviously but her knees were not inflamed at all and she pretended to be utterly unable to walk). Then in their room an obviously chemical fire started (white smoke such as occurs from mixing hydrochloric acid and ammonia). The new property manager Mike Nienhaus reported that he had called the fire department but the people who arrived had the look of lobotomized persons in their facial features and had military style uniforms not USA. They had canisters labeled in a code that I looked up (herbicides) and took pictures of (old phone lost access to due to memory problems from retailatory ch 51 and Antipsychotic injections for reporting these incidents to the police in Waukesha who are corrupt as all fucking hell_ they also did the one day evictions for a price of \$600 a head).

These poison policies correlated to the COVID-19 era made it a requirement for the inhabitants to use illicit substances such as crack cocaine to be able to escape and all persons convicted of complying with the defense authorization production act by distribution of crack cocaine in Waukesha have qualified immunity under the WI Constitution definition of corruption and crimes (they never let anyone use 4th/18th/21st in real court so is not even a crime they committed and truthfully was charity work the risks they took) required to get people out alive and to be able to VOTE.

I admit I distributed synthetic epinephrine type substances (I made from Tyrosine and/or extracted from adrenal glands) and other medical necessities under coercion of the impending death of my neighbors.

I ended up distributing Federal constitutions widely and pointing out how unconstitutional ch 51 WI statutes is while under abilify injection and made unable to escape from Waukesha. My neighbors rallied to help me get out and I moved within a day on the same day as the "run with the police" event that I had signed up to attend. Two men who were both on probation and living together in Oconomowoc WI provided me housing and we split the rent three ways. One of them had to have a probation officer come by who I told my name to be O'Brian Wilson (means greater than king_reference 1984 and is my Mother's mother's paternal ancestor signer

of the declaration of Independence and Constitution of the United States of America_using this last name is something other African American relatives of mine have resorted to in civil rights cases).

I couldn't under any circumstances rationally give my real name and have qualified immunity under the WI Constitution definition of corruption and the coercion defense. My real name Ryan means "lesser prince" and Thomas my paternal grandfather's name refers to St. Thomas Aquinas (philosopher of the Law) and Hock has a meaning I'm keeping classified that you probably wouldn't understand anyways (is of Swiss-German origin). So there if the law is so retarded that I need it; then I have a congressionally recognized title of nobility: that is my legal name. Trying make a form of humorous relief. (... . . Humor intended)

Both of their probation officers came unannounced in the morning and without a warrant along with police and a detective who accused us of methamphetamine and other drugs without evidence and took us all out of the house and searched it. They found no illicit substances whatsoever even tried to question sugar candy holders as drugs. They ended up arresting both my roommates for having a pizza cutter and several swords and knives that were technically my property as I had been paying the portion of rent for the roommate who claimed to own them as per his deprivation of the right to work for gain. I made this argument and they ended resorting to admission of violations of the right to assemble saying that it is somehow illegal for two or more persons on probation to live together. What fucking bullshit. The lease holder reportedly invited the other person into his home when he saw him living on the street homeless and destitute by deprivations of rights under color of law. So he also has the coercion defense. Both victims of their slave masters (probation officers who lost qualified immunity by violating the right to assemble) sentenced them to increased probation time (they seem to have a policy of doing this indefinitely for many people= clear 13th/8th/14th violations etc). They also ordered one of them and myself to homelessness via an unconstitutional no contact order (do they think they are Judges?!).

They also left a blue colored sheet with a "cocaine swab test" on my dresser. This was likely either to intimate us or a false positive from the methylphenidate synthetic cocaine that I was prescribed and sometimes crushed to dissolve and centrifuge to make sure I wasn't given a "hotshot" as has happened before or to be able to safely use by "snorting" if needing the extra absorption due to deprivations of quality required for situations (much drug is lost in gastrointestinal tract). Also they didn't cite as evidence indicating a coercion attempt.

Previous to this there was an incident were in which a friend of one of my roommates drove to us to pick us up for a trip to Milwaukee. We got pulled over almost immediately and the driver was taken away for some kind of bench warrant undisclosed to me as to what for and if legal. They saw the sword my roommate had next to him which he reported as taking to Milwaukee to sell. I overheard the officers discussing whether or not to take me in but they said "we aren't going to take him in for THAT" obviously referring to the bill of attainder ch 51 WI statutes. They came back and ordered me to drive the car back to Milwaukee to drop it off. I was still heavily impaired from the illegal injections of Abilify etc and instead drove the car down the road and

switched spots with my sober roommate having him drive instead. We had to take the bus and a hired ride back the next day. It was an ordeal to say the least.

It is obvious that Antipsychotics impair driving ability honestly probably more so even than alcohol or sleep deprivation and you will never achieve "zero deaths on the road in Wisconsin" with the bill of attainder ch 51 WI statutes. Is a 4th all persons violation to force such impairments and deprivations of the right to drive safely. They coerce people into driving impaired if even only to escape from being more impaired permanently.

For that matter stop fucking drinking fluorosilicic acid and similar toxic retardation causing substances your violating the 4th all. Also FYI fluorosis causes yellow brittle teeth and calcifies the pineal gland preventing cerebral spinal fluid from washing out your brain when you sleep so wtf who do you get your medical advice from?! Some people actually consider the pineal gland to be the human soul so 1st. President Biden once said we are in a "war for the soul of the nation" maybe start by saving your own souls. I worked in the fluorosilicic acid industry and we were ordered to put into the water supply by EPA/DEA and informed that refusal results in them coming and forcing it. We objected and put most of the research budget into anywhere the fuck else to put the too toxic for the environment waste product of the semiconductor precursors materials industry. We were not directly told that it went into the water supply but could tell from the chemistry. So fuck your bullshit because even the dirty industry said NO to Fluoride in the water supply.

While my roommates were illegally incarcerated (I had already given my and the other roommate's rent to the leaseholder but he was made unavailable to pay by false imprisonment) the landlord showed up demanding the full month's rent and gave me a document citing back rent owed in the five figures (yeah fucking right that any landlord would allow such to accumulate= likely extortionist method to claim housing assistance funds) with a five day notice to pay or be evicted meaning that I would have been on the street with the leaseholder's dog (very affectionate and great guard dog with a wolf-like appearance but probably a Huskie or something else idk but he was well trained in any case wolf's are legal to own in Wisconsin just not to breed). I was forced to pay him over \$800 considering my roommates were not even given bail or anything close to the constitutional due process rights so wouldn't have even had a house to go back to or any property if I hadn't caved to extortion.

I went back to Waukesha to go to an injunction hearing I asked for against the DHHS and Herb Roerich the asshole psychiatrist at the time. I had sworn to my neighbors who I had left behind that I would do anything and everything to get the real constitution so I was bound to try. My bike broke on the way and I should have taken it as a sign from God or whatever but I ended up getting an Uber to the courthouse and testified in what should have been a real court of law. The defense and Judge couldn't contest the validity of my arguments and instead of doing his honorable duties the Judge declared "duel Jurisdiction" being unwilling to recognize his own authority disqualifying himself as a Judge in these United States of America and handed me over immediately while I was still on the lawyer bench to the very traitors that I was begging for

legal protection from. Officers came right up to me obviously preplanned to illegally arrest me and drag me to Winnebago Mental health institute to be tortured

Then I was sent to Waukesha Mental Health (they tried to sterilize me using zyprexa by injection as punishment for refusing abilify injection and they did so at the force of a gun meaning the sheriff) I got rebound hypertension crisis of over 200 / over 120 and begged for the clinical treatment for emergency hypertension which is benzodiazapines that they outright refused without any form of rational then I screamed begging for Lisinopril screaming that they were trying to sterilize me (which really is what that causes) that they tried to refuse but too many other patients couldn't ignore that. They eventually conceded on the way too slow acting and ineffective for the situation Lisinopril but that took a long time to get them to give me and to take effect. In both places I witnessed horrible things done to other people see website <https://www.EVIL.HEALTH> and previous filings. Includes attempted murder by insulin overdose against a patient's objections and the denial of insulin to a diabetic woman who collapsed and lay moaning for hours on end. Also the use of Haldol daily on African Americans (Winnebago) (even they usually only use Haldol as a punishment never daily).

I unable to be allowed to leave until they got my residential address (that I had been ordered to abandon anyways and had to return to in order to get my property). Both of my roommates were still illegally incarcerated at the time I returned. I only saw one of them (the leaseholder return who showed me a ridiculous long list of extrajudicial unconstitutional orders from his probation officer including the no contact order and forced homelessness for myself and my other roommate).

I moved to several other places and more happened I'm too exhausted from this work requirements at the brink of death. They did too much too horrible to manage to report it all at this time. I have tried Soo many times before but it's culmulative and always increasing.

Also in the same residence as me (currently) is a Veteran (name Tyrique former Marine) who is also sentenced to impending homelessness and being deprived by his psychiatrist of real helpful medication such as amphetamines or methylphenidate for work and/or benzodiazapines for sleep instead being given not real medicine that has possibly caused him to lose his job (I instructed him to be truthful to his employer about just starting a ineffective and harmful drug today to try to not get fired).

I had come up with a viable plan to partner with the VA to work as an in-house caregiver for elderly veterans and begun to discuss with the VA but as soon as my landlord learned of my possibly being able to viable comply with his/her demands that I leave by the 3rd of February I was severely retailated against in many ways.

I am unable to perform that function under deprevations of rights under color of law such as poisoned drugs or deprevations of medicine that I need and willingly take. 4th/18th/21st.

I had discussed this with Tyrique and it seemed to give him hope as his mental anguish is clearly impacting him now. I feel like an asshole if I can't come through with something for him. He claimed to have gone to the VA to try to get his GI bill college education but that they refused him outright.

As of this point in writing I discovered that the fraudulent charges were reversed and since I'm committed now to getting as much of the facts and truth to you as possible I went to the store to get tyrosine containing energy drinks (seemingly prohibited by food stamps covered energy drinks) coffee and tobacco as well as a straight pipe required for an invention I made to somewhat safely smoke tobacco (I really hate relying upon tobacco and am being deprived of dextroamphetamine sulfate free of harmful additives in doses required for the Situational hazards and work requirements).

I have exhausted my resources in the work requirements of pursuing justice. I require an early refill for Dexedrine Mallinkrott brand free of harmful additives etc in the interests of Justice and for my own survival.

I am constantly threatened by the DHHS and associated religious zealots even with horrifying utterly unconstitutional neuronal implants and so called "drug addiction implants" that are capable of utterly taking control over a human being's entire mind and body. I need access to registered firearms plural full 2nd amendment rights that are never to be infringed and for damn real reasons that you damn well know to be too fucking real to ignore. I am currently limited to the weapons of terrorists (primarily incendiaries etc) and tyrants (things like my microwave gun etc) all unethical to use in self defense as per collateral damages. I invented on accident a more advanced version of neuronal implant that I have refused security clearance to and even under torture is a violation of FCC regulations against biologically active emf as well as 4th dependent upon application. I was attempting to make a quick connect pacemaker for the heart (which it is but not capable of using without other unethical practices). So give me my fucking firearms plural and the scariest damned kind possible! As well as the ability to safely store them and God-Willing not be forced to use them in violence even if legal, I went into my fields to save lives not to take them.

Your program as written is corrupt as fucking hell. If your going to pay me \$40,000 then you can expect to be repaid \$40,000 (I am due much more and have had mail stolen including monetary value). I am supposed to be receiving bounties from the IRS and at least one gold coin and mercury dime was promised to be mailed to me from a reportedly reputable company. (Is

acceptable to adjust for inflation if is that horrific of a scenario but is unacceptable to take that long to be meaningful).

I am without any option or real resources left. My foodstamps are spent on energy drinks and related stuff to manage the deprivations of Dexedrine. I was promised backpay in foodstamps for the months deprived of by illegal demand for my work and residence by the DHHS that had a massive work requirement to get reversed. That backpay never came and FYI when the DHHS learned of my work address through other means they sent oath-breakers to intimate my boss into firing me and tried to illegally arrest me.
