I implore you to Declare your Independence from the Rebel Alliance of the DHHS and DEA sourced from the United States but without our consent or blessings.

The above is not fitting your website's definition of communication that is not warranting a response as you are not asked to interfere with foreign policies only to assert your own rights as an independent Kingdom and Commonwealth of Freedom and Liberty as you self determine. Frankly my people need to see you do that to be inspired in these horrific times.

The following is needed to know information, and indeterminate if you want to invoke that privilege stated.

Greetings and Salutations my name is Ryan Thomas Hock and I am writing you out of severe desperation for the soul of my country that is under the rule of a violent rebellion composed of the Department of Health and Human Services (DHHS) and the Drug Enforcement Agency (DEA) who seemingly has made an alliance with the Taliban (my country is a Empire of the

Constitutional Republic and as an Empire has never ever I'm history that I know of abandoned military bases in any location occupied. They did not make a peace treaty with the Taliban but an alliance that is fitting the cultural similarities of those three entities of the religion married to the state that is defined by Christianity Judaism and Islam by the practices of self mutilation such as Antipsychotics and mood stabilizers Azo dyes etc tactics of the ongoing rebel alliance activities (self mutilation=Baal) and the worship of Moloch defined by human sacrifice particularly of children meaning the legally vulnerable such as the elderly and disabled as well as the illegally incarcerated and tortured for amusement masses not guilty of any constitutionally valid crime(s) as clearly understood and defined by our supreme laws including the (4th/18th/21st Amendments) that needs no further explanation other than to read them.
