This petition/motion is in response to a

An appearance of “Deprivations of Rights Under Color Of Law” of many Tribes/Nations but in Particular the Menominee who were relatively recently plundered/pillaged/raided whatever you want to call the technically acts of War without Congressional Approval committed by one or more of at least three possible government entities all of the executive branch and apparently rewriting the records to blame each other.

I needed to communicate with them openly and honestly regarding a Matter Of:

National Security

Specifically: Economic Stability of the Currencies
and a Partial Solution to the Inflation and Responses expected from the Federal Reserve Bank
