

Pharmacies are obviously defined as distributors of pharmaceuticals. I am aware that in the very recent past pharmacies did operate and own their warehouses and mass distribution centers. I am told that this is not the case for at least the Milwaukee WI pharmacies who go through other distributors who sometimes give them what is asked for and more often something that is a poisoned knockoff. I also got evidence of old pills from mislabeled manufacturers being sold indicating that the DEA take back program or police evidence locker or some other atrocities of 4th violations are the source. This is particularly concerning for the medication I need to survive and thrive (along with other things that are reasonable to expect) dextroamphetamine sulfate free of harmful additives etc. As that would only go to the DEA take back program after death of the patient or illegal incarceration at a psych ward (they stole my prescription of Dexedrine at Ascension Columbia St Mary's Mequon WI psychiatric ward claiming to have destroyed them. I questioned if they took it to manufacture methamphetamine to do controlled sales and entrapment or to use themselves to counter the antipsychotics that they never admit to be harmful. I was not refuted.

Manufacturers allow distributors to directly purchase from them. For example Mallinckrodt brand Dexedrine (dextroamphetamine sulfate free of harmful additives etc) is available on their website for a minimum purchase order of \$300 = meaning you have to buy more than a months supply at a time and therefore also be capable of meeting future increased demand and not make the lucky ones into hated persons for getting special treatment not available in any reasonable timeframe for if told the benefits to others. Your needing to be able to help more than one person at a time or too much is expected of us alone.

So therefore if your chosen or something else distribution center/entities are unable or unwilling to adhere to Truth in Advertising laws then you are obligated by your contacts to provide strategic resources for truly medical purposes including enhancement of function voluntarily taken substances (such as the obviously discriminated against amphetamines and methylphenidate (synthetic cocaine) as well benzodiazepines and other voluntarily taken substances that are never poisons.

The fact is that in almost every case I have found that only the imported from allied nations pharmaceuticals have not been corrupted utterly by violations of truth in advertising and 4th/8th/13th and more. This is likely because instead of only one regulatory government agency (obviously the private sector is supposed to have sufficient resources including self defense to be able to also guarantee constitutional adherence). In the United States of America produced for sale here that only includes the FDA. If from a friend foreign power they also have at least one local government regulator, their export customs and our import customs making a minimum of 4 government regulators plus the private sector of both the manufacturer abroad and the purchaser locally making it 6 regulatory steps to never be able to lie to each other or even have the legal capacity to obey each other in the at least 2 different governments that don't change at the same time and rate.

Note: enslaving us that manage to get real medicine is not okay and I'm very upset with my being subjected to a bill of attainder (ch 51 WI statutes) that makes me need to beg you to do

what you already know you need to for the general welfare and mutual defense. I Ryan Thomas Hock have been an utter slave or livestock for at least 5-6 years now and trafficked from organ harvesting center (psych ward and group home to trap house to trap house under all manner of deprivations of rights under color of law and outright violent illegal actions done with impunity. The times I managed to get the real version of Dexedrine that is not poisoned has multiple times saved both my own life and others but was unable to make up for the things that should have murdered me many times over to show it's true value as a real non-psych enhancement of function and ability to pursue happiness.

This needs to solve this deprivation of medicine that is real once and for all for everyone who is willing to voluntarily take drugs that are for improvement of well-being not the entertainment of sadistic malevolent unconstitutional prevailing powers.

This does not include the truly only illegal as per the violations of 4th recreational substances (the Azo dyes versions are only useable short term without major dependency and increasing doses that eventually lead to the loss of free will are therefore purely recreational (in an illegal and sadistic way of the psychiatrist's and associates recreation not the patient) and are for harmful purposes).
