After reading this you might feel compelled to offer me enlistment opportunity but I'm currently unsure of how that would impact my legal status regarding my cases in Federal Court and ability to succeed in civil suits etc. Also the fact is that after being subjected to the bill of attainder ch 51 WI statutes and the associated poisons/tortures I am now utterly drug dependent to be able to function and perform. It is not a thing that is acceptable to me to make a precedent of being ok with the military. I hope you understand.
