Problem:

Food Share card is not renewed and renewal process requires disclosure to an entity within the DHHS of the address of and name of employer(s). Was made to be dependent upon government benefits such as food-share through the Bill of Attainder/ law impairing the obligations of contracts called Ch.51 WI Statutes.

I was instructed by official channels to contact the legislature regarding this issue. This obviously means that I can't just ask for a solution to my problems but must offer a solution(s) that benefit the People in general/solve a problem that you can use to your advantage politically/to advance your own moral agenda(s) that the Constitution permits.

So many people can't tell the DHHS where they live and/or work for very legitimate reasons and/or simply rational prudence. The majority seem to be demanding some form of minimum essential income not based upon titles of nobility such as DSM-5 marks of the beast required to get the ability to buy or sell if destitute and needing social security income etc well-fare type things. The DHHS of at a minimum Waukesha County is acting in violation of the Federal and State Constitutions and the obvious requirement of a functioning Judicial system of the security of a free state/ protection of witnesses and victims from their assailants; via the continued attempts to have me illegally arrested, tortured and murdered most likely in a hospital setting where organs are easily harvested (they refuse to honor my advance directive forbidding Antipsychotics etc unethical/unconstitutional rituals of their DSM-5 based religion/Theocracy.

So IDK if you are allowed to accept the compensation of shares and possibly also benefit plan(s) I'm offering to the People of the Constitutional Republic regardless of citizenship, nationality etc who swear to defend and uphold the Constitution of the United States of America as written, strictly interpreted and plainly understood and who keep that oath. Personally I don't understand how not profiting/benefiting personally from your position is even possible if you are making decisions that benefit the general welfare. **Case No. 22-CV-668-JPS** (Filed in the Milwaukee Federal Building)

Ryan Thomas Hock V. Office of the Secretary (OS) of the Wisconsin Department of Health Services (WDHS) & Division of Care and Treatment Services (DCTS) of the WDHS & et. Al

I originally filed against the whole of the DHHS (Federal, State and County) for the use and execution of "Bills of Attainder" that "impairs the obligations of contracts" such as Wisconsin's Ch.51; however the Court determined to amend that because I was harmed by ch.51 which is a state bill of attainder not federal; I can only at this time pursue actions against the WI DHHS. I filed a request for reconsideration on the national grounds that every state has some version of this type of bill of attainder and the international grounds of the DHHS run concentration camps along the border where they are murdering children with antipsychotics.

The court is at this time not allowing me to pursue all the causes of action I listed. I am currently being allowed to pursue claims of:

- 1.) Unlawful arrest and false imprisonment, as I was taken into custody multiple times without cause or warrant
- 2.) Due process claims, as I was confined without notice or opportunity to be heard and that I was similarly forced to take medications.
- 3.) A claim of Excessive Force, as I was forced to take antipsychotics by use of violence
- 4.) Tort claims of assault and battery for incidents stemming from being required to take unwanted medications

I filed a request to reconsider the claims of:

- 1.) Human Trafficking
- 2.) Slavery in violation of the 13<sup>th</sup> amendment
- 3.) Obstruction of Justice

I also feel obligated to inform you that I received contradictory information regarding the court date scheduled for 10/20/2022. The online circuit court posting indicated that it was to be a zoom appearance.

The court papers taped to the door were irregular in that the person serving the documents was not identified by name. There was no Judge assigned only a court commissioner. The paper documents indicated that appearance was mandatory. This is never true of an eviction proceeding. I always have the option to not appear or to send counsel in my stead.

The zoom option seems to be the only option. The concern is that I previously (the BOA suit mentioned previously) was swayed to appear by zoom instead of in person (COVID-19) and the so-called court commissioner was wearing a (I think yellow) bandanna as a mask and relatively young and had an unlikely hairstyle for the position. The main concern though was that he refused me a Jury trial in violation of the WI Constitution article 1 section 5 (trial by jury in all civil cases) and Article 1 Section 9 (right to obtain justice freely without the obligation to pay for it\_ Waukesha Courthouse demands \$20 which I didn't have) and muted when I objected, then rendered judgment. The issue is myself and BOA agreed to go to jury trial. I later filed other paperwork with the court and asked them if the assigned commissioner was young and had a yellow bandanna and they responded in the negative.

FOIA (release to the public): Silver Alert. Are we being made to act as “fugitive slave catchers?” Where are they fleeing from and why? What is their legal competency status and prescribed drug list? Can you require that any hunted in such a manner be given immediate housing such as in a motel/hotel and the right to testify in public court on public record and free of unconstitutional impairment(s)?

FOIA (the public needs to know the Facts to prevent civil war): Satellite as well as ground based reportings of emf fields and abnormalities at least spanning the last 10 years. Purpose to determine source of electromagnetic weapons used against individuals silenced from testifying to such competently by unconstitutional impairment(s) and to commit voter suppression. Regardless of your instinct to deny this the people know these weapons exist and are used as per publications, admissions in writing from the governments, and because it has been self-evident also because we have them ourselves (We simply know we cannot use them except possibly as a last stand idk the sterilization, cancers, etc things like microwave guns cause is hard to excuse and really IDK if even applicable to defend against an assailant as a strong enough blast to incapacitate or kill is unlikely to not cause collateral damages). The consensus is split as to if the use of these weapons is government sourced (foreign and/or domestic) and/or the unconstitutional use by individuals and/or or other null hypothesis(es).

I suspect a combination. In at least one instance the appearance of an attempt to use destructive interference was noted but that could have been a ruse. I can and have testified as to having been targeted by that class of weapon in correlation to the controversial Biden V. Trump Presidential election. I experienced symptoms of electrical jamming of brainwaves preventing complex thought and causing physical impairments. I was too sick to report and work as a poll worker as a result. I managed to vote but know it was coerced/impaired by this undeniable use of electromagnetic weaponry. I was unable to manage to read all of and comprehend Biden's plan as I normally would have. I am guilty of allowing myself to fall victim to a form of implied coercion and that was that I knew I would at least have been able to make effective efforts to defend myself from that kind of assault and battery if I had money and therefore do my duty to the Constitutional Republic and vote competently and informed and in the interests of us all. At the time I was being deprived of Social Security Disability/ Supplemental Security Income on the grounds of refusing to accept a payee who would be leverageable to force me to live in a group home or other form of pen/slave quarters. I also knew that I could never admit any form of incompetency especially financial as that would be used against me in the unconstitutional involuntary commitment proceeding(s). They made me need SSDI/SSI to survive and tried to attach strings to make it impossible to use beneficially.

I based my decision to vote for Biden/Harris on the grounds of the democrats need to provide social well-fare support to maintain their chosen image regardless of other outcomes. I really wouldn't have voted for either Trump or Biden in that election if not under undue unconstitutional suppression. Biden coupled banning assault rifles to increasing funding for the “mental health” system the deterrence of which is the primary reason to have a registered assault rifle. Trump either ignored or never received my plans/ communications intended for him/others as relevant as well including the public but much was particularly oriented towards the new administration's stated goals and plans and might have really prevented the horror story that occurred.
