It is clear that in any state planned economy (USA is a combination of planned and private/free market) the elimination of any job(s) within the planned sector results in a degree of difficulty in adapting to work in other fields. Therefore the smoothest transition should include an option for employment that they are well-suited for and is within the confines of the Constitution.

The 4<sup>th</sup>, 18<sup>th</sup> and 21<sup>st</sup> Amendments are clear, plain and easily understood to mean that the prohibition of any voluntarily taken recreational and/or medicinal substance(s) must be done only via specific Amendment to the Federal Constitution that names the prohibited substance specifically or as a class. Example the 18<sup>th</sup> prohibited “intoxicating spirits” not ethanol specifically. They knew this to be a violation of the right to be secure in your person (includes medical self-determination), and it turned out to be an utter disaster leading to the 21<sup>st</sup> amendment which sets the precedent of prohibitions that violate constitutional right(s) are not in-line with our Republic and Constitution upon which it stands.

They are Soo hated by the rest of society that it is practically impossible if not utterly impossible for them to be able to expect to find work in other Constitutionally Compliant positions: Government or Private.

Writ of Mandemous:

End the Date Rape Pills and punishment injections / Treasonous use of Antipsychotics as weapons to negate the work requirement generated by having competent co-workers and/or to undermine the 1<sup>st</sup> amendment. This is not to be misinterpreted as a prohibition of real medications like diazepam but will require the extension of prescribing powers to Pharmacists for example to prescribe diazepam for emergency hypertension or serotonin syndrome and/or excitotoxicity as the psychiatric cartel oftentimes leverages their monopoly over benzodiazapines (minor tranquilizers) to require/coerce co-prescribed Antipsychotics (Major Tranquilizers much more useable for Date Rape and Human Trafficking etc than the benzodiazapines). The prescribing by pharmacists can allow for equivalent to patient availability for chronic conditions like sleep but will still be obtained as needed without requiring the stockpiling of quantities usable in unconstitutional manners; because of the much higher availability of pharmacists and much more scientifically valid understandings of the advantages and disadvantages of drugs compared to psychiatrists

FOIA: What The Fuck happened to the publications on propylene glycol toxicity and the FDA regulations prohibiting the use in food?! Why is propylene glycol used as “hospital gas to prevent viruses?!” They didn't include a mechanism for this. Propylene glycol desiccates lung tissue and exacerbates problems with respiration such as COVID-19.

FOIA: Why is Molybdenum being added to vitamin supplements? / if the biproduct product of Thorium Nuclear then is the purpose to track individuals and/or to confuse the people watching for radiological hazards?

FOIA: How many of those associated with the DEA were prescribed Antipsychotics? This includes family members and friends. In what doses and what chemical(s)? Did they get accepted because of the threat of physical lobotomy? Please voluntarily disclose your medical records to the public. I am aware of at least one instance of law enforcement using a man prescribed antipsychotics as a narc. He was known to sell poisons as if it were Adderall in violation of Truth in Advertising. They wouldn't accept illegal search as a defense even though it was a stop and search while walking down a bike trail. They wouldn't accept or even provide valid rebuttal to constitutional arguments. They refused change of venue request etc.

When I was denied due process for over two years and not permitted to use constitutional defenses and possibly targeted by electromagnetic weapons to deprive higher thought I petitioned the people for a solution explaining that I was being denied the only demand I made of my lawyer who I wasn't permitted to choose but had to pay: that my case go to jury trial and no plea deals made. I had told them that the document I was made to sign was coerced at the time I signed it (part of it said I was saying that I was not acting under coercion), and I begged them to let me bust someone for a real crime. I was not given time to find any real criminals as I did not associate with such.

I knew that the threatened 10+ year sentence for possession of \$15 worth of Opium that Judge Malloy of Ozaukee County was demanding (also my initial Ch.51 Involuntary commitment Judge who admitted to remembering me during his sentencing me to death via involuntary “medications.”) to be unrecoverable and unlikely to be survivable or in any way allow any form of significant contributions to society afterwards. The known reality is that the ex-cons are sorted by type of offense and the harshest discrimination from government and government-regulated businesses is reserved for drug-offenders who must be kept in poverty to maintain the propaganda image. I had during those two years made a public speech specifically accusing the corrections corporation of America of Human Trafficking and Slavery in Violation of the 13<sup>th</sup> via lobbying for unconstitutional laws like marijuana prohibition and cited the public records of such. Going to any form of jail or prison after such is unlikely to be survivable.

I was given a target (Shaun Sigmound unknown spelling) by consensus of the people who was a known Narc and also guilty of selling poisons as if they were beneficial/needed medications he was also prescribed and sometimes sold. I attempted to setup a buy for his sometimes Adderall sometimes Poison but the officers coercing me said they didn't care about Adderall. So I agreed to meet the target to buy “Rolls” however he simply lead me to another person while we were under observation to buy from. He was honest about the ingredients being MDMA and Cocaine. He only identified himself as “lover.” He had a police scanner that was buzzing with chatter and I so much so can't forgive myself for not warning him somehow. He was supporting a family with an infant child to have a reasonable standard of living in the suburbs. His refrigerator had alphabet characters I could have used to make an SOS or something. I know my soul is Damned to Hell. They demanded that I purchase a quantity that was gaurunteed to be resulting only in Cruel punishments so severe as to be unrecoverable. I was later

informed that he was coerced into the same. Therefore I don't know how many Persons I am responsible for destroying the lives and futures of in an utterly unconstitutional and unethical manner.

Possibly as a self-preservation mechanism or possibly real, I made a secret contract with either or both God and Satan and possibly Lilith IDK to dedicate my life to finding some way to make up for what I had done and earn forgiveness from the people I harmed or worse. I am ineligible to be forgiven by God, Satan Lilith or whomever else that is not the victims of my True Crime. My soul is bound to this and I had actually made progress towards this goal as I figured the only way I could make up for crimes done against victims I couldn't easily identify was to end death=the artificial organs etc b/c that would at least give them another lifetime or more to make up for the ones I cost. Now I know that I can't save my own soul due to "Laws Impairing the Obligations of Contracts" such as Ch.51 and the unconstitutional prohibitions and the violations of Anti-Trust Laws that are used to restrict and prohibit even the real medications they say are available to those who need them (ex. Dextroamphetamine sulfate). I refused to accept or apply for the expungement of the not even a real crime or even under their unconstitutional system punishable as per "fruit of the poison tree;" because I was not coerced by ineligibility to work in unconstitutional government positions, I was coerced only by not having any productive or meaningful possibilities at all. I am guilty of Human Sacrifice and am damned.

FOIA

It is suspected that the DEA "Take-back" program is a source of the adulteration of MDMA pills aka "rolls" with unwanted additives in violation of "Truth in Advertising" such as Antipsychotics which have been reported to be in some of those pills by independent regulators? One very rarely admitted reason for using serotonin increasing drugs like that is not strictly recreational but also for the purpose of recovering from the damages of Antipsychotics to the emotion-based cognition as well as the ability to feel satisfied/able to relax after accomplishing goals. The illicit drug market has since more or less adapted by primarily doing away with "rolls" in favor of pure chemical powder.

Where does the drugs they get donated go?

What drugs/doses/formulations and in what quantities did that program receive and when?

I was misquoted by the District Attorney for Waukesha WI: Brian Running in the unconstitutional Ch.51 so-called court as supposed evidence of my insanity as having said that: "the DEA ordered me to Manufacture Methamphetamine." I immediately corrected him and replied as is on public record (my old Facebook profile\_lost access to due to forgotten password as a result of forced brain damages from antipsychotics and situations arising from that) that I had said: "The DHHS ordered me to manufacture Methamphetamine via the order given by injections of Haldol the biochemical opposite of Methamphetamine which makes Methamphetamine the closest known antidote to the poison Haldol. The witnessing of the victims given even more Haldol than the two injections forced violently upon me results in coercion too great to expect any ethical person to resist. I did my best to comply with the ethical demand by posting the proper/safest manufacturing method publicly. I also distributed ephedra sinica seeds to numerous basically random persons saying it was a gift of the defense production authorization act; which the strictest interpretation of is that it was. I also informed them that even though this is the plant that all amphetamines are made from, not even the DEA could prosecute them for teas and topicals even under

current unconstitutional policies. COVID-19 contributed to the coercion to get that plant to the people as it is a bronciodialator (makes breathing easier).

The argument given to me to try to convince me to accept their religion by psychiatric nurses is that: our new 2<sup>nd</sup> Amendment right to replace firearms is the poisons they give us the initial option of stockpiling (you tell them you are better and they only make you pick up/have paid for the substances they prescribe as if medication, you tell the truth and they run the gambit of poisons followed by injections if you still refuse to comply with aiding and abetting their Treasons), selling as date rape drugs or slipping to others as implied by their statement: “haven't you heard of making yourself smarter by making others dumber?” The reality is the only time I saw a member of the DEA in person and in uniform he had the symptoms of Antipsychotic exposure (facial features bordering on hydrocephaly, an uneven distribution of fat etc). When seen on the television they are always young and in peak physical fitness.

I have only one memory of seeing a DEA personal in person and that is when my house was raided on false accusation given by paramedics of running a Methamphetamine lab based upon having chemical oxygen generators to flush the atmosphere of chronic gas leaks and carbon monoxide. I had no choice but to call 911/ an ambulance because a neighbor stumbled into my house and passed out from hypoxia as I measured his pO<sub>2</sub> to be in the range of 30% (normally upper 90's%) meaning immediate risk of brain damage and death. They assumed drug overdose even though I told them the pulse oxomiter reading and gave him multiple doses of nasal narcam without effect. They did provide breathing support and take him to the hospital. After they left the police, bomb squad, and DEA came to my house and asked me to come outside to talk. (they only saw that if they don't have a warrant but are going to detain you). I immediately begged not to be taken to the psych ward and instead they handcuffed me and put me in the back of a police vehicle as they raided my house.

I admitted openly to having a drug lab; which I did: it was for R&D of novel medications to reverse the effects of Antipsychotics that are not scheduled and even if they became scheduled I would always have the right to manufacture and have them as per the “rights of inventors and useful artists.”

As I was making things like derivatives of tyrosine, inducers of neuronal growth factor production without brain damage, and derivatives of medications protected as religious sacraments from any form of prohibition; they couldn't legally charge me. I didn't keep most forms of improvised weapons in weaponized form and they had dual purposes for the most part (it was very difficult to motivate myself to invent things that maim/harm or kill so I compromised and made things that had other non-weapon uses for the most part), meaning the bomb squad found nothing as well.

I got very concerned when I was allowed to go back inside because I couldn't find one of my most dangerous to handle materials: a powered concentrate of a microscopy dye that if exposed to could cause permanent blindness and cancers/major physiological problems that likely lead to death. So I ran outside to the cop car still posted outside my house and begged them to only open that container (a metal shaker for alcoholic beverages with crumple zones inside etc) in a “Glove-box” (a term for a sealed atmosphere container for handling hazardous chemicals). Within a few days time the container and contents reappeared apparently without compromise of the material containment.
