    - Active and valid UEI numbers are a requirement to receive federal funding.

#### Student Paid Lunch Prices for SY23-24 (Diana)

- The Paid Lunch Equity (PLE) Tool for SY23-24 has been released. You can find a copy of the tool in the iCAN SNP Download Forms.
- Schools with a zero or positive balance in their Nonprofit School Food Service Account as of June 30,
   2022 will not be required to raise paid lunch prices for the 23-24 school year. These schools will not be required to fill out their PLE tool.
- o There is no PLE waiver for SY23-24 allowing schools to lower their paid lunch prices.

    - USDA provides additional guidance on bulk meals, identifying rural areas, CANS reviews, and monitoring. Sponsors who are adding a Grab and Go site must ensure that a visit occurs within the first 2-weeks of operation.
