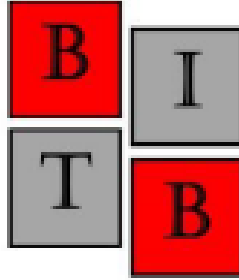

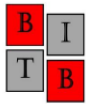

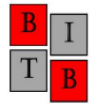

TOURNAMENT RULES



FORMAT: Team event; (4) bowlers per team, all men, all women, or mixed. Teams will bowl (3) games. Handicap based on 90% of 220 per game. Battle In The Bay Tournament will be sanctioned through USBC. Bowlers must have a current USBC sanction card to participate in this tournament

TEAM ENTRY: A team may enter the tournament multiple times provided one (1) member on the roster has changed.

ENTERING AVERAGE: All averages must be 21 games or higher as posted on USBC Bowl.com . Entering averages will be derived as follows: (1)The highest average for 2023-2024, will be used as the entering average to include Summer averages. If no 2023-2024 average is available, then the highest average, from 2022-2023 with 21 games or more will be used. If the bowler does not have an average for either year, then the bowler may use his/her current league average with 21 games or more. Any bowler unable to submit an average based on the above criteria will bowl scratch with an average of 220. Ten pin rule will apply in computing entering averages.

AVERAGE RERATE/ADJUSTMENTS: If a bowler's average has been rerated or adjusted in any tournament, that bowler must notify the tournament director to avoid disqualification from the tournament in accordance with USBC rule 319C.

SCORING FORMAT: The teams (3) ten pin score plus handicap will determine the overall teams score .

TEAM ENTRY FEE & BREAKDOWN: The entry fee, is \$260.00 per team entry, \$65 per bowler. Of the \$65.00 entry fee per bowler, \$50.00 is allotted for prize fund, \$15.00 is allotted for lineage and expenses.

SCRATCH & HANDICAP SINGLES: Bowlers have the option to participate in the Team Scratch, Handicap Singles, or Scratch Singles event while bowling the team event. There will be male and female divisions for both the scratch and handicap optional events. All optional fees will be applied toward the optional prize fund 100%. Of the total entries 1:4 will cash. Bowlers may cash multiple times. **APPLICATIONS WILL NOT BE ACCEPTED WITH PARTIAL PAYMENTS. Optional events must be paid with the entry application NO EXCEPTIONS.**

OPEN BRACKETS AND SIDE POTS: Handicap and Scratch High Game entry will be available with male and female divisions. Open Scratch and Handicap Brackets will be available.

CASH RATIO/PRIZE FUND DISTRIBUTION: Of the total team entries, 1:8 will cash. Total pins plus handicap will determine standings from 1st place to the final paid position. Teams that cash will have four individual checks mailed to the Team Captain, and the Team Captain will be responsible for distribution of those checks.

Any rules not addressed or covered in the tournament rules will be subject to and governed by USBC rules.
