

- 1. This league known as Tuesday Mixed League is a **Managed League**. Tuesday Mixed League will consist of a 4 team member roster. The league will allow for (2) designated subs to be placed on your league roster for a maximum of a 6 member roster. **Designated subs are permanent for the duration of the season.**Designated subs cannot be interchanged for new subs throughout the season. The only instance where a designated sub can be released/removed from a team is if they are becoming a permanent member of another team that has a vacancy position (See USBC RULE 110/C).
- 2. Tuesday Mixed League will meet for 36 weeks at 7:00pm beginning August 12, 2025, ending on April 28, 2026. The league **WILL NOT BOWL on December 23<sup>rd</sup> and December 30<sup>th</sup>, 2025.** Tuesday Mixed League will be sanctioned through USBC. **All members will be required to fill out a USBC sanction card** to indicate what league they will sanction through for the 2025/2026 season. Sanction cards through Orlando Regional Bowling Association are \$25.00. Members have the option to purchase sanction cards online at <a href="https://www.bowl.com">www.bowl.com</a> prior to the start of the season.
- 3. Tuesday Mixed League officers are as follows:

- 4. Tuesday Mixed League will have three (3) twelve-week sessions, with a position round on the 12<sup>th</sup> week of each session. Position rounds will take place on October 28, 2025, February 3, 2026, April 28, 2026. Payout will take place on May 5, 2026. All win/loss will convert back to zero after each position round.
- 5. Tuesday Mixed League is a **GUARANTEED LINEAGE LEAGUE**. In the event of absence, the bowler is required to pay league fees in full upon return. The league bowling fees are \$30 per week per bowler. The league will allow for a bowler to be no more than one (1) week in arrears. The team will be responsible for any shortages due to nonpayment of fees at the time of payout. Bowling fees must be paid weekly at the control desk to a league officer prior to bowling. Forms of payment accepted: cash, check, money order, or cashier's check made payable to FTL or Florida Travel League. Debit/Credit card payments will be accepted, however the square processing fee of 2.6 % plus .15 cents per swipe will be passed to the bowler. (Visit squareup.com for current fees)
- 6. On a bowler's 3<sup>rd</sup> consecutive absence **WITHOUT PAYMENT** a vacancy score of 150 **WITH NO HANDIAP** will be used for the bowler's spot. Any shortages due to nonpayment of bowling fees will become the responsibility of the team.
- 7. If for any reason a check is returned to the league for nonpayment, \$38 NSF fee plus the amount of the check must be paid before the member will be eligible to bowl. The member will not be allowed to write checks for the remainder of the season.
- 8. The last (2) months of bowling fees must be paid on or before March 31, 2026.

- 9. In accordance with USBC rule 121a, a member withdrawing from the league must give two weeks' notice along with cause for resigning from the league. It will be to the team's discretion to divide prize fund monies between the resigning bowler and the replacement bowler. If a bowler does not give notice and leaves the league, then in accordance with USBC rule 121a (2) all prize fund monies for that individual(s) will be forfeited. The team will be responsible for any outstanding fees that are due for vacancies.
- 10. There is no team cap for this league. Individual handicap will be 90% of 220. Bowlers returning to Tuesday Mixed League from the previous season will return with their ending average provided a minimum 21 games were bowled. All others will use their highest USBC book average from 2024-2025 as shown on Bowl.com A bowler without an average will establish their average after bowling the first 3 games. Entering averages will be used for the first 9 games (3 sessions). A vacancy score of 150 with no handicap shall be used.
- 11. One member of the team's roster shall constitute a legal line up. A team must have a legal line up at the start of league play otherwise game(s) are forfeited until a legal line up has been established.
- 12. A tardy bowler may enter the game **provided the third (3rd) frame has not been COMPLETED by both teams.** The bowler will be allowed to make up the missed frames.
- 13. Tuesday Mixed League will use (9) point system. The 9 points will be achieved in the following manner: Teams will receive (2) points for each game won (6 pts max), and (3) points for total handicap team series won.
- 14. NO **POST BOWLS** will be allowed in this league. The league will allow for PRE BOWLS except during position rounds. All pre bowls MUST BE COMPLETED by Sunday prior to the league meeting on Tuesday's of each week. Team Captains must notify the League Manager, or League Officer, in advance for any pre bowls. The league will allow for an individual or the entire team to prebowl. All prebowled scores must be accompanied with an official print out from the center to be counted as official scores.
- 15. When bowling against an absent team, the present team must bowl within 40 pins of their team's scratch average to earn the two (2) points per game. The team must bowl within 120 pins of their scratch average to earn the (3) points for team series.
- 16. ALL TIES (Win/Loss) on the standing sheet will be determined by Handicap pin count from first to last place.
- 17. If any of the Bylaws conflict with USBC rules, then the League Manager has final say.
