# TOURNAMENT RULES



**FORMAT:** Team event; (4) bowlers per team, all men, all women, or mixed. Teams will bowl (3) games. Handicap based on 90% of 220 per game. Motion To Strike Tournament will be sanctioned through USBC.

**TEAM ENTRY:** A team may enter the tournament multiple times provided one (1) member on the roster has changed.

**ENTERING AVERAGE:** Entering averages will be derived as follows: **(1) COMPOSITE AVERAGE** for 2024-2025, as listed on bowl.com will be used as the entering average. If no 2024-2025 composite average is available, then the **COMPOSITE AVERAGE** from 2023-2024 will be used. If the bowler does not have a composite average for either year, then the bowler will enter tournament with scratch average of 220. In the event a bowler's current reported composite average is 10 pins greater than previous season, the higher average must be used. Ten pin rule will apply when computing entering averages.

**AVERAGE RERATE/ADJUSTMENTS:** If a bowler's average has been rerated or adjusted **IN ANY TOURNAMENT, FOR ANY YEAR** that **BOWLER MUST NOTIFY THE TOURNAMENT DIRECTOR** to avoid disqualification from the tournament in accordance with USBC rule 319C.

**SCORING FORMAT/LANE CONDITION:** The teams (3) ten pin score plus handicap will determine the overall teams score. Lanes will be oiled with the same pattern between each squad. **THE LANE PATTERN UTILIZED FOR THE TOURNAMENT WILL NOT BE DISCLOSED.**

**TEAM ENTRY FEE & BREAKDOWN:** The entry fee is \$55.00 per bowler, \$40.00 prize fund, \$15.00 for lineage and expenses.

**SCRATCH & HANDICAP SINGLES:** Bowlers have the option to participate in the Team Scratch, Handicap Singles, or Scratch Singles event while bowling the team event. There will be male and female divisions for both the handicap and scratch optional events. All optional fees will be applied toward the optional prize fund 100%. Of the total entries 1 of 6 will cash. Bowlers may cash multiple times. **OPTIONAL EVENTS WILL BE ACCEPTED THE DAY OF THE EVENT (1) HOUR PRIOR TO EACH SQUAD. NO OPTIONAL ENTRIES WILL BE ACCEPTED ONCE PRACTICE BEGINS EACH SQUAD.**

**OPEN BRACKETS AND SIDE POTS:** Handicap and Scratch High Games will be available with Male & Female Divisions. Brackets will be available with (3) Divisions: DIV (1) HCP 199 average & below, DIV (2) HCP 200 average & above, and DIV (3) Open Scratch

**APPLICATION ENTRIES / MAILING ADDRESS:** APPLICATIONS WILL NOT BE ACCEPTED AFTER THE DEADLINE. PAYMENT FOR ENTRY MUST ACCOMPANY APPLICATION. NO PARTIAL PAYMENTS WILL BE ACCEPTED. **CASH RATIO/PRIZE FUND DISTRIBUTION:** Of the total team entries, 1 of 8 will cash. Total pins plus handicap will determine standings from 1<sup>st</sup> place to the final paid position. All prize checks will be mailed to the team captain.

Any rules not covered here will be rendered by the Tournament Director, and those decisions will be final.
