Notice: The Township has received the Pension Allocation for 2024 of \$20,170.90. The check to PSAB MRT is included in the bills presented this evening.

Notice: The Township has received the State Foreign Fire Tax Allocation of \$33,692.75. The check to Saxonburg Vol. Fire and Relief Assn. is included in the bills presented this evening. The sec/treas. will prepare the report 706B required by the state.

The sec/treas., appointed representative to the Butler County Tax Collection Committee (BCTCC), attended their bi-annual meeting on Sept. 24, 2024. The current contract ends on 12/31/26. They are working on an 'early renewal' and asking the municipalities and school districts if they agree with an early renewal. The current cost deducted from the receipts of the Earned Income Tax is 1.45%. They are looking at a 7-year option (first 3 years at 1.40%) vs. a 10-year option (first 4 years at 1.40%) ... whichever is offered, the percentage after the discount period will go back to 1.45% (as is currently charged.)
