

RESOLUTION #523

A RESOLUTION REVISING AND RE-ESTABLISHING the fees for permits and inspection services for the Township of Jefferson.

WHEREAS, the Board of Supervisors of Jefferson Township has adopted a codification, consolidation, and revision of the ordinances of the Township, and;

WHEREAS, it is the desire of the Board of Supervisors of Jefferson Township to eliminate all permit fees and inspection fees from the Code of Ordinances and enact them instead by resolution;

NOW, THEREFORE, BE IT RESOLVED and it is hereby resolved by the Board of Supervisors of Jefferson Township that all fees are hereby fixed as follows, until such time as a new resolution is passed.

BUILDING PERMIT/CONSTRUCTION INSPECTION FEES

- SEE RESOLUTION #426 adopted 1/7/19 (effective 2/1/19).

EXCEPT FOR:

A Township Administrative Fee - 20% of any inspection fees or minimum \$130.00, whichever is higher added to the total inspection costs for permits for any structure '1,000 sq. ft. or more' requiring enforcement under the PA UCC *PLUS* a \$250.00 fee that is reimbursable only upon completion (final inspection) or issuance of the occupancy permit by the PAUCC inspector. This fee is not reimbursable after 2 years.

SEE Township Review Certificate (below) for accessory detached structures under 1,000 sq. ft. for single family residential lot purposes.

TOWNSHIP REVIEW CERTIFICATE:

Accessory detached structures (i.e. sheds, carports, greenhouses and above ground pools) under 500 sq. ft.)

- Minimum Fee \$60.00

500 sq. ft. up to 1,000 sq. ft. - Minimum Fee \$130 or 20% of any inspection fees, whichever is higher.

Structures under 100 sq. ft. - i.e. sheds and outbuildings for single family residential use - no fee required.

EXCEPT FOR: Agriculture (Farm) Accessory Structures- (*for qualified farming operations deemed exempt from PA UCC) *Must be a qualified farming operation as defined in the Internal Revenue Code, as amended and/or falls under the definition of 'agricultural' in the PA UCC.

Includes sheds, barns, and buildings primarily used for qualified farming operations.

Township Review Certificate - Minimum Fee \$60.00 plus 20% of all inspections if structure exceeds 4,000 sq. ft.

LOGGING/HAULING/WEIGHT LIMIT PERMITS:	\$300.00
COPIES - (8 1/2" x 11") <u>per side</u> (twenty-five cents)	\$.25
