As a candidate (nominee), I understand that MCEA will not be able to take care of all expenses related to either assembly. A delegate must attend at least five (5) meetings of the Executive Board and Representative Assembly of MCEA during the 12-months prior to the assembly for which he/she is elected in order to receive full funding. Failure to comply with this rule will result in a reduction in monetary allocation of 1/5th for each meeting less than the five (5) attended. The sign-in sheet and the official minutes of these meeting will be the only documentation accepted to verify attendance.

If elected as a delegate, I am aware that I will be expected to follow the guidelines adopted locally or at the state level. If I do not attend at least 75% of the business meetings, I understand that MCEA will collect from my monetary allocation, the same percentage of meetings that I missed. I recognize that it is my obligation to be informed on the issues before the respective assemblies by attending the MCEA Representative Assembly and other Local Association Meetings. Further, I recognize that it will be my duty to inform the membership of my voting and other the issues that were decided. I understand that, if elected, I am obligated to attend the AEA/NEA Assembly unless prevented by emergency conditions.

According to the MCEA Constitution, Article VIII, Section 1, Delegates should be in good financial standing, be an active participant in constituted committees, workshops and activities sponsored by the Association, and attend at least five (5) Executive Board and/or Representative Assembly meetings during the year (12) months prior to the Assemblies. According to the MCEA Constitution, Article 3 Section 1: Qualifications - All officers of the Association shall have been members of the local, state, and national association for a period of at least two years, attended a minimum of 5 Executive Board/Representative Assembly meetings per year, and shall maintain such membership during their term of office.
