- 2. Family Cart Plan:** This plan is suitable for situations where both a husband and wife are playing separate games simultaneously and require two carts. The cost is **\$1,100 per year or \$91.67 per month.**
- 3. Trail Fee:** If you have your own cart, you can opt for this plan. Your cart must be white and have no mud tires to be approved by the general manager. The cost is **\$600 per year or \$50 per month;** If you live in The Sloan Lake neighborhood, the cost for this is **\$750 per year or \$62.50 per month.**
