- 1. That they are both residents of Harrison County, Kentucky, over the age of 18 years, and under no legal disability;
- 2. That the affiant Betty Thomas Darnell is the Secretary, and the affiant Emmett Daniel Clifford is the Senior Warden of the Church of the Advent Episcopal, also known as the Cynthiana Episcopal Church, and are authorized to make this affidavit on behalf of said church;
- 3. That the church desires to clarify the record regarding the legal description of the property owned by them, as conveyed by Henry and Elizabeth Cromwell, by Deed dated February 2, 1834, and of record in Deed Book 24, page 448 in the Harrison County Clerk's office, which description has since been rendered illegible;

This indenture made and entered into this 2nd day of February 1834 by and between Henry Cromwell and Elizabeth his wife of the one part and George Perrin and William Thompson, Trustees for the protestant Episcopal Church in Harrison County of the other part WITNESSETH that the said parties of the first part for and in consideration of the sum of four hundred Dollars in hand paid the receipt of which is hereby acknowledged have given, granted, bargained and sold and by these presents do grant, bargain and sell to said parties of the second part for the use of said church to erect a house of public worship and for any other

purposes to which said Church may wish to dedicate the same, the following described piece of land lying adjoining the town of Cynthiana on the east side of the back street of said town and bounded as follows, viz: commencing at one hundred feet north of the northwest corner of Margaret Beans lot thence East back to the rail road and thence North with the railroad one hundred feet thence West back to back street thence South one hundred feet to the beginning. To have and to hold said piece of land and every part thereof to said Trustees for the uses and to their successor forever. And the parties of the first part do hereby covenant and agree that they will forever warrant and defend the title to said land hereby conveyed against all claims whatever. In testimony of which said Cromwell and wife have hereunto set their hands and seals the date first above written.
