MEMORANDUM

On July 8, 2020, you were served with process at your current address via United States Postmaster – certified mail (Article no. 7019 0140 0000 7156 5532) with the Affidavit of Fact: Writ of Quo Warranto [Exhibit: A], and were given three (3) days from that date to answer and produce for the record proof of jurisdiction and the evidence commanded therein. A copy of the Writ of Quo Warranto was received by foreign European female Penny Penn, (acting as) District Attorney for the OFFICE OF THE DISTRICT ATTORNEY FOR FORSYTH COUNTY, Inc. by service of process at her current address via United States Postmaster – certified mail (Article no. 7018 1130 0000 5657 5335) on or about July 08, 2020. As of this date there has been no answer and jurisdiction was not proved to exist, which constitutes DEFAULT.

Your omission serves as conclusive proof of the proceedings in this case along with any judgment, order and attachments filed therein by you (et al.) being unconstitutional, notwithstanding, null and void ab initio for lack of jurisdiction and fraud; and serves as your admission by silence to the claims and monetary damages demanded in the Affidavit of Fact: Writ of Quo Warranto [Exhibit: A] in the amount of \$2,148,500.00 payable in lawful money of .9999 fine gold bullion coins or bars. In support, see the stare decisis law in the case **Elliot v. Peirsol, 26 U.S. 328, 340 (1828)**, where it was decided by the Supreme Court of the United States that, *"Courts are constituted by authority and they cannot act beyond the power delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers."*

I make no claim with respect to the title/nom de guerre/ alleged defendant CHARMAINE LILLIAN JACKSON (Race: Black/African-American), and I hereby surrender and assign any and all reversionary interest therein to the account of the UNITED STATES CORPORATION COMPANY / UNITED STATES (Inc.) and subsidiaries for full acquittance and discharge settlement and closure of case no. 20M-1494-A / 2020050374 pursuant to and in reliance on Title 12 United States Code § 95(a), Part 2; and I do not accept any liability nor do I consent to stand as surety for CHARMAINE LILLIAN JACKSON at any point or moment in time.

ORDER

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that I, Kia Aqeel El Bey (hereinafter "Judgment Creditor") shall recover from you, Leslie Abernathy-Maddox (Administrative officer/clerk), Walker H. Bramblett (Administrative officer/clerk), Greg G. Allen (Administrative clerk), Penny Penn (district attorney), as well as Samuel Roberts #3101,(first name undisclosed) Colter # 2333, Ron H. Freeman (Sheriff), FORSYTH COUNTY SHERIFF DEPARTMENT (Inc.), CIRCUIT COURT FOR FORSYTH COUNTY (Inc.), and STATE OF GEORGIA (Inc.) (hereinafter "Judgment Debtors"), along with the Judgment Debtors' successors in interest, the judgment as follows:

- i. The dismissal with prejudice and withdrawal from the record of citation no. 20M-1494-A / 2020050374 along with any attachments associated thereto for lack of jurisdiction and fraud;
- ii. Total sum certain amount of 2,148,500.00 in lawful money of .9999 fine gold bullion coins or bars.

IT IS FURTHER ORDERED, that this judgment shall serve as a judgment lien against the oaths of office, surety bonds, and all other property and assets of the Judgment Debtors' and their spouses, their heirs, successors and assigns, in order to secure the performance of this judgment, and to levy on such property and assets for the satisfaction of this judgment if payment cannot be made. See **Sniadach v. Family Finance Corp., 395 U.S. 337 349 (1968)** (*"The ability to place a lien upon a man's property, such as to temporarily deprive him of its beneficial use, without any judicial determination of probable cause dates back not only to medieval England but also to Roman times."*).

IT IS FURTHER ORDERED, that the Judgment Debtors' and their spouses, their heirs, successors and assigns forfeit their rights and property under the organic 13th Amendment, section 12, of the Constitution for the United States of America 1791, which aver the following:


Section 12: "The traffic in slaves with Africa is hereby forever prohibited on pain of death and the forfeiture of all the rights and property of persons engaged therein; and the descendants of Africans shall not be citizens."
