### RELEASE ORDER

By the Affidavit for Writ of Habeas Corpus Ad Subjiciendum [Exhibit: A] attached hereto and having been sworn to by our Sharif officer Akeem Rashaad El Bey (or by his deputy), before me this day, based upon facts asserted therein, it is this \_\_5th\_\_ day of \_\_October\_\_, 2020, hereby ORDERED that our national Kia Aqeel El Bey [ex rel. CHARMAIN LILLIAN JACKSON, DOB: DOB: 11/02/1992, ID No.: 2133632] be forthwith RELEASED from your custody without condition or delay;

It is further **ORDERED** that this writ shall be EXECUTED pursuant to your obligation to uphold and support the Constitution for the United States Republic of North America under Article VI, clause 2, as well as the provisions of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire under Articles 6 and 20, as shown in the attached affidavit [Exhibit: A];

It is further **ORDERED** that there shall be no cause for delay in the execution of this writ. See stare decisis law in *Kolovrat v. Oregon, 366 U. S. 187, 194, 81 S.Ct. 922 (1961)*, which the Supreme Court of the United States decided the following:

"A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities. Under the supremacy clause of the United States Constitution Art. VI, clause 2, state policies as to the rights of aliens to inherit must give way to overriding federal treaties and conflicting arrangements."

I, Akeem Rashaad El Bey ("Affiant"), of lawful age, and being first duly sworn upon affirmation, deposes and says:

I am a Sharif officer with the Consulate of Morocco in the Georgia state republic. I hold delegation of authority to exercise the functions and duties of the Office of the Sharif with the Consulate of Morocco in the Georgia state republic, and to exercise consular jurisdiction over the person and property - estate of our Moorish American Nationals in the Georgia State republic territory in accordance with the provisions of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire.

I have first-hand knowledge and information of our Moorish American National Kia Aquel El Bey being presently denationalized and held hostage for profit as somety for no

guerre CHARMAIN LILLIAN JACKSON, DOB: 11/02/1992, ID No.: 2133632, [Race: Black] in unlawful imprisonment under color of state law, under the custody of Victor Hill, (acting as) Sheriff for CLAYTON COUNTY, Georgia, at the following location:

I further assert that the unlawful imprisonment was due to the following circumstances:

- On October 2, 2020, near the corporate COUNTY OF CLAYTON, Georgia state republic, our Moorish American National Kia Aqeel El Bey was exercising her right to travel, and was arbitrarily detained and eventually kidnapped, denationalized as a civilly dead stateless person, and held hostage for profit as surety for CHARMAIN LILLIAN JACKSON (race: black) under the custody of Victor Hill, (acting as) Sheriff for CLAYTON COUNTY, Georgia, by an unidentified armed male highwayman, doing business as policeman / employee / contractor of the foreign CLAYTON COUNTY POLICE DEPARTMENT (Inc.).
- 2. As a result, our national Kia Aquel El Bey is presently being held hostage as prize and deprived of her liberty under color of state law within purview of the plausible 14<sup>th</sup> Amendment, contrary to and in violation of the supreme Law of the Land under Article VI, clause 2 of the Constitution for the United States Republic of North America.

Because of which, this is an international treaty matter which comes under the jurisdiction of the Consulate of Morocco in the Georgia state republic, and our national Kia Aquel El Bey is to be immediately released by such consular jurisdiction per Articles 6 and 20 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, which aver the following:

Article 6. (in relevant part) ...if any Moor, not a subject of these dominions, shall make prize of any of the citizens of America, or their effects, and bring them into any of the ports of his Majesty, they shall be immediately released, as they will then be considered as under his Majesty's protection.

Article 20. If any of the citizens of the United States, or any persons under their protection, shall have any disputes with each other, the Consul shall decide between the parties, and whenever the Consul shall require any aid or assistance from our government, to enforce his decisions, it shall be immediately granted to him.

WHEREFORE, Affiant requests that the honorable Consulate of Morocco in the Georgia State republic issues a writ of habeas corpus ad subjiciendum and release order according to law, directed to Victor Hill, (acting as) Sheriff for CLAYTON COUNTY, Georgia, and to Jacquline D. Wills, etc., (acting as) Administrative clerk of the foreign corporate entity SUPERIOR COURT FOR CLAYTON COUNTY (Inc.), commanding that they forthwith release the body of our national Kia Aqeel El Bey as provided by federal common law under Articles 6 and 20 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, and the stare decisis law in the case Kolovrat v. Oregon, 366 U. S. 187, 194, 81 S.Ct. 922 (1961), which the Supreme Court of the United States stated the following:

"A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities. Under the supremacy clause of the United States Constitution Art. VI, clause 2, state policies...must give way to overriding federal treaties and conflicting arrangements.".

NOTICE OF LIEN OF JUDGMENT is hereby given and a Judgment Lien is hereby taken in favor of Nailah El Bey as Consul for and on behalf of Kia Aqeel El Bey (hereinafter "Lien Creditor") and against the property and assets of acting Sheriff Victor Bernard Hill, acting Chief Administrative clerk Wanda L. Dallas, acting Administrative clerk Jacquline D. Wills, and acting District Attorney Tasha Mosley (hereinafter "Lien Debtors") for default and breach of constitutional

and treaty obligations under Article VI, clause 2 of the Constitution for the United States of North America, and under Articles 6 and 20 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, by failing to execute the duty in the Writ of Habeas Corpus Ad Subjiciendum – Release Order which was duly served upon the Lien Debtors (principal and / or agent) on or about October 7, 2020, via United States Postmaster certified mail with return receipts (article numbers: 7019 0160 0000 4879 0886 for Jacquline D. Wills; and 7019 0160 0000 4879 0879 for Victor Bernard Hill) for the purpose of enforcing such treaty obligations for the immediate release of the Lien Creditor from being denationalized and forcibly assimilated under the unconstitutional 14<sup>th</sup> Amendment U.S. corporate citizenship clause, while being held hostage for profit in unlawful imprisonment and involuntary servitude as surety for the fictitious corporate person / nom de guerre: CHARMAIN LILLIAN JACKSON, DOB: 11/02/1992, ID No.: 2133632 (race: black) under the custody of the Lien Debtor, Victor Bernard Hill, and there being no answer or cause to the contrary made by any of the Lien Debtors, it is therefore considered:

ORDERED AND ADJUDGED that a judgment lien be and the same is hereby entered against the Lien Debtors;

It is further ORDERED AND ADJUDGED that this judgment lien shall extend to and cover all property and all rights to property, real and personal, corporal and incorporeal, of the Lien Debtors and their spouse, their heirs, successors and assigns as long as this judgment lien is not fully satisfied, and the property and rights to property of the Lien Debtors, et al., shall include, but shall not be limited to, the following:

Any and all oaths of office, public surety bonds, lands, hereditaments, common property /
community property, intellectual property, commercial property, automobiles, boats,
aircrafts, bank accounts, future earnings, wages, and pensions;

It is further ORDERED AND ADJUGED that the said property of the Lien Debtors may be levy upon at any time by the Lien Creditor or by any consul agent of the Consulate General of Morocco at the Georgia state republic acting on behalf of and in the interest of the Lien Creditor, and such property shall be held as security until this judgment lien is fully satisfied;

It is further ORDERED AND ADJUGED that if this judgment lien is not fully satisfied by the Lien Debtors within thirty (30) days from the received date of this judgment lien by Lien Debtor, Jacquline D. Wills, then the Lien Debtors forfeit all of their property and rights to property unto the Lien Creditor under this judgment lien in accordance with the organic 13th Amendment, section 12 of the Constitution for the United States of North America, which aver the following:

"The traffic in slaves with Africa is hereby forever prohibited on pain of death and the forfeiture of all the rights and property of persons engaged therein; and the descendants of Africans shall not be citizens."

It is further ORDERED AND ADJUGED that the acting Public Defender Adeline

Alexander (hereinafter "Third Party Interloper") is notwithstanding in this case and does not under
any circumstance represent the Lien Creditor or the nom de guerre CHARMAIN LILLIAN

JACKSON, and the appearance of the Third Party Interloper is therefore void ab initio and

stricken from this case along with any filings and attachments associated thereto.
