1. Plaintiff Adeyinka Kaylah Selestani Bey (also known as Kayla Selestani-Bey) a natural person, in full life, in propria persona, sui juris, aboriginal and indigenous Moorish American national of the Moroccan Empire at Maghrib Al-Aqsa, North-West Amexem/ North America by jus sanguinis, having a mailing location of C/o 2214 Poplar Falls Avenue Lithonia, Georgia republic. Plaintiff is properly identified by their Allodial National Identification Card, which is

registered under certification number AA 222141, Class A, with the Zodiac Constitution in the Library of Congress Copyright Office at Washington, District of Columbia, and the United States Department of Justice.

2. Defendant Gurdeep “Sunny” Bhatia is an unknown foreign person subject male, and a resident of Georgia having a mailing address known as 2014 Iris Drive Southwest Conyers, Georgia republic [Near. 30094]. Defendant Gurdeep “Sunny” Bhatia is also an employee / contractor acting as Chief Executive Officer of the foreign corporate entity CREATIVE ATLANTA LLC (Inc.) doing business as EVOLUTION CARS LLC (Inc.) within purview of the plausible 14th Amendment.

3. Defendant Eugene King is a stateless person subject male under the unconstitutional 14th Amendment U.S. corporate citizenship clause, and a resident of Georgia having a mailing address known as 2014 Iris Drive Southwest Conyers, Georgia republic [Near. 30094]. Defendant Eugene King is also an employee / contractor acting as General Manager of the foreign corporate entity CREATIVE ATLANTA LLC (Inc.) doing business as EVOLUTION CARS LLC (Inc.) within purview of the plausible 14th Amendment.

4. Defendant Duane Bell is a stateless person subject male under the unconstitutional 14th Amendment U.S. corporate citizenship clause, and a resident of Georgia having a mailing address known as 2014 Iris Drive Southwest Conyers, Georgia republic [Near. 30094]. Defendant Duane Bell is also an employee / contractor acting as Finance Manager of the foreign corporate entity CREATIVE ATLANTA LLC (Inc.) doing business as EVOLUTION CARS LLC (inc.) within purview of the plausible 14th Amendment.

5. Defendant Brittany Stephenson is a stateless person subject female under the unconstitutional 14th Amendment U.S. corporate citizenship clause, and a resident of Georgia having a mailing address known as 2014 Iris Drive Southwest Conyers, Georgia republic [Near. 30094]. Defendant Brittany Stephenson is also an employee / contractor acting as Finance Manager of the foreign corporate entity CREATIVE ATLANTA LLC (Inc.) doing business as EVOLUTION CARS LLC (inc.) within purview of the plausible 14th Amendment.

6. Defendant Don Hankey is a foreign occidental European subject male, and a resident of California having a mailing address known as 4751 Wilshire Blvd #100 Los Angeles, California republic [Near. 90010]. Defendant Don Hankey is also an employee / contractor acting as Chairman of the Board of the foreign corporate entity WESTLAKE FINANCIAL SERVICES (Inc.) within purview of the plausible 14th Amendment.

7. Defendant Bret Hankey is a foreign occidental European subject male, and a resident of California having a mailing address known as 4751 Wilshire Blvd #100 Los Angeles, California republic [Near. 90010]. Defendant Bret Hankey is also an employee / contractor acting as Vice Chairman of the foreign corporate entity WESTLAKE FINANCIAL SERVICES (Inc.) within purview of the plausible 14th Amendment.

8. Defendant Ian Anderson is a foreign occidental European subject male, and a resident of California having a mailing address known as 4751 Wilshire Blvd #100 Los Angeles, California Republic [Near. 90010]. Defendant Ian Anderson is also an employee / contractor acting as Group President of the foreign corporate entity WESTLAKE FINANCIAL SERVICES (Inc.) within purview of the plausible 14th Amendment.

9. Defendant Paul Kerwin is a foreign occidental European subject male, and a resident of California having a mailing address known as 4751 Wilshire Blvd #100 Los Angeles, California Republic [Near. 90010]. Defendant Paul Kerwin is also an employee / contractor acting as Chief Financial Officer of the foreign corporate entity WESTLAKE FINANCIAL SERVICES (Inc.) within purview of the plausible 14th Amendment.

10. Defendant Tim Taylor is a foreign occidental European subject male, and a resident of California having a mailing address known as 4751 Wilshire Blvd #100 Los Angeles, California Republic [Near. 90010]. Defendant Tim Taylor is also an employee / contractor acting as Vice President of Accounting and Corporate Controller of the foreign corporate entity WESTLAKE FINANCIAL SERVICES (Inc.) within purview of the plausible 14th Amendment.

JURISDICTION AND VENUE

11. Jurisdiction in this case is based on diversity of nationality and consular jurisdiction.

12. Adeyinka Kaylah Selestani Bey is an aboriginal and indigenous Moorish American national of the Moroccan Empire at Maghrib Al-Aqṣá, North-West Amexem / North America by jus sanguinis, and an inhabitant at the Georgia state republic under the consular jurisdiction of the Consulate of Morocco at the Georgia state republic. As such, Adeyinka Selestani Bey is classified as a "foreign national" as that term is used for the purposes of consular notification and the instructions in the United States Department of State Consular Notification and Access manual 5th Edition 2018.

13. The Defendants, Gurdeep "Sunny" Bhatia, Eugene King, Duane Bell, Brittany Stephenson, are U.S. corporate citizens under the unconstitutional 14th Amendment U.S. corporate citizenship clause and are residents at the Georgia state.

14. The Defendants, Don Hankey, Bret Hankey, Ian Anderson, Paul Kerwin, and Tim Taylor, are foreign occidental Europeans and are residents at the California state.

15. This Morocco Consular Court at the Georgia state republic has competent jurisdiction and proper venue to hear and decide this case under consular jurisdiction at the Georgia state republic by authority of Articles 20 and 21 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, and Article III, section 2, and Article VI, section 2 of the Constitution for the United States of North America

STATEMENT OF FACTS

16. On or about November 8, 2020, Complainant negotiated a deal with Respondent(s) for the keys to and for the black 2017 Audi Q7 VIN# WA1LAAF74HD016768 at Respondent(s) private corporate location c/o 2014 Iris Dr SW Conyers, Georgia republic [Near. 30094].

17. On or about November 8, 2020 Complainant gave a promissory note for \$55,740.80 as well as \$4,700 Federal Reserve Notes in exchange for the keys for and to the black 2017 Audi Q7 VIN# WA1LAAF74HD016768.

18. On or about November 17, 2020, Complainant was requested to return to Respondent(s) private corporate location c/o 2014 Iris Dr SW Conyers, Georgia republic [Near. 30094] to correct an error and renegotiate said deal.

19. On or about November 17, 2020, Complainant returned to Respondents(s) private corporate location c/o 2014 Iris Dr SW Conyers, Georgia republic [Near. 30094] in the black 2017 Audi Q7 VIN# WA1LAAF74HD016768 and gave another promissory note for \$56,657.12 with an additional \$300 Federal Reserve Notes to correct and secure said deal, for the already retrieved keys for and to the black 2017 Audi Q7 VIN# WA1LAAF74HD016768.

20. On or about December 31, 2020 around 12:30am EST to 1:00am EST, Respondent(s) had someone with a towing truck trespass on Complainants stepfather's private residence c/o 758 Stephenson Rd Stone Mountain, Georgia republic [Near. 30083] and committed Grand Theft Auto by stealing the black 2017 Audi Q7 VIN# WA1LAAF74HD016768, which also possessed \$2,722.88 worth of Complainants personal property in it.

21. The witness of the grand theft auto is the Complainants stepfather Barrington Barrett I.

QUO WARRANTO

22. THE DEFENDANTS AND THIRD PARTY ARE HEREBY COMMANDED to produce the following as proof of jurisdiction and lawful authorization for the seizure of Plaintiff private and personal property related to the black 2017 Audi Q7 VIN# WA1LAAF74HD016768.

- a. A certified copy of a lawful seizure warrant signed and issued by an Article III Court of competent jurisdiction with the attached written accusation in support being signed under oath or affirmation by an injured party pursuant to the 4th Amendment of the Constitution for the United States of North America.
- b. Produce both 'original promissory notes' (front and back) associated with the loan from your agency / entity / persons to the creditor, dated November 8, 2020 and November 17, 2020 which obliges the Plaintiff to any corporate statute or rule, or to a specific performance by their free consent.
- c. Produce any 'allonge', 'Bill of Exchanges, and / or 'Promissory Notes' (front and back) complete with any affixations or allocations attached to the 'creditor promissory note' for endorsements.
- d. The name, address, and telephone number of your public hazard and malpractice bonding company, and the policy number of the bond, and if required, a copy of the policy describing the bonding coverage of your specific job performance as officers/employees/contractors of the CREATIVE ATLANTA LLC (Inc.) doing business as EVOLUTION CARS (et al).
- e. Proof of lawful service of process being made upon the Plaintiff as a prerequisite before attempting to deprive them of their private property (the automobile in question).
- f. Proof of your delegation of authority order/license from Georgia state republic to sell automobiles.

- g. Produce all bookkeeping journal entries associated with the loan to the creditor.
- h. Produce all 'call reports' and related 'notes' made for the period covering the loan.
- i. Produce the 'deposit slip' for the deposit of the creditor's 'promissory note' associated with the loan.
- j. Produce 'verification' that the creditor's 'promissory note' was a 'gift' to the 'lender' from the creditor.
- k. Produce the 'name' and the 'address' of the current 'holder' of the creditor's 'promissory note'.
- l. Produce the 'name' and 'address' of the lender's CPA and auditor, for the period covering the execution.
- m. Produce a copy of their legal authority to do business in the Georgia republican government sanctioned under Article 4 section 4 of the United States Constitution for the North America republic.
- n. Produce evidentiary authorization to levy surcharges.

DAYS OF GRACE TO ANSWER

23. The Defendants have three (3) days from the receipt of this Affidavit of Fact:

Writ of Quo Warranto to answer and produce the above evidence or will be subject to a Default Judgement.
