

Terms of Service

1. Agreement to Terms

These Terms of Service ("Terms") constitute a legally binding agreement between you (an individual or entity, "you" or "your") and Formation Inc ("Company," "we," "us," or "our"), a healthcare staffing and recruitment agency. The arbitrator's decision shall be final and binding, and judgment on the award rendered may be entered in any court of competent jurisdiction.
- If you prefer, you may bring a claim in a court of competent jurisdiction in California. The parties irrevocably consent to the exclusive jurisdiction of the state and federal courts located in Los Angeles County, California.

12. Severability

If any provision of these Terms is held to be invalid, illegal or unenforceable by a court of competent jurisdiction, then that provision will be eliminated or limited to the minimum extent required, and the remaining provisions of these Terms will remain in full force and effect.
