LIMITED COMMON ELEMENTS**

**ADD**

Including the elevator or lift added to the exterior of Bedford B, Inc.

**Elevator or Lift**

Unit owners desiring an elevator or lift added to the exterior of Bedford B, Inc. shall be permitted to install such elevator to our building at the said expense of said Unit Owners sole expense. Unit owners who add a lift or elevator voluntarily bind themselves, their units, and subsequent owners of their units to pay the full cost and expense, shared on a pro rata basis, with other said unit owners who so voluntarily act for the installation, insurance, operation, maintenance, repair or replacement of the elevator or lift added to the building.
