#### **OPENING REMARKS**

Assemblywoman Sheila Leslie, Chairwoman, welcomed members, presenters, and the public to the seventh meeting of the Legislative Committee on Health Care. Chairwoman Leslie gave a detailed introduction to the hearing process, the reason for the special hearing, how the Committee would conduct business during the meeting, and how the information and testimony gathered would be used by the Committee.

#### Statement of Nevada Governor Jim Gibbons

Governor Gibbons introduced Michael J. Willden, Director, Department of Health and Human Services (DHHS), and Andrew Clinger, Director, Department of Administration. Governor Gibbons stated that he has been in constant contact with State officials to resolve the hepatitis C crisis Nevada is currently undergoing. He explained the timeline of the flow of information and the corrective actions taken subsequent to the discovery of unsanitary practices at ambulatory surgical centers in Las Vegas. Governor Gibbons reported on agency hiring processes underway to assist in resolving these issues.

- Chairwoman Leslie invited Dr. Evelyn McKnight of HONOReform to testify.
- Dr. McKnight explained that she is a fellow citizen who has also acquired hepatitis C via a medical facility. She explained her experience of contracting hepatitis C from a medical center while undergoing treatment for breast cancer and the genesis of her work today for the nonprofit Honor Reform. Dr. Mcknight stated the goal of Honor Reform is to make health care more responsible.
- Chairwoman Leslie noted that Dr. McKnight will return to testify at the April 21, 2008, meeting of the Committee.
