AFFIDAVIT OF EDDIE REEDOM

Eddie Reedom, being first duly sworn, deposes and states as follows:

A) This day December 11, 2007 I demand that the Official Office or Agents Of the Attorney General, District Attorney, Mayor or Metro Police do make official arrangements for an immediate Press Release or News Conference. Wherein Officials of The City Of Las Vegas Shall Denounce the Video Taped Hate Crimes, Assaults and Violent Acts of Intimidation & Fraud against Eddie Ray Reedom. By Dan Towbin, Josh Towbin and or their Employee's. Failure to do so may result in further liability, Negligence and a one billion dollar lawsuit. Based on Metro Denying my Right to Report Violent Crimes, City Council Rejecting My Written & Live Pleas For Help And To Report Systematic & Violent Crimes By Towbin & Staff, Abuse Of Power By City Council & Violation Of The Klu Klux Klan Act Of 1871 For Intimidating Me With Extra Police – For Prejudicial Treatment By Public Display Of Anger, Hate, Yelling, Defamation and By Removing My Fact Based Free Speech Public Statements On Mr. Dan Towbin's Character From Official City Council Records on 08-01-07. While Treating All Other Speakers With Respect And By Allowing All Positive Character Witness Statements For Mr. Towbin To Enter Official City Records (Including Statements or Letters By Senator Townsend and possibly Illegal Testimony Of A High Ranking Military Official "Which Causes Me To Fear My Own Military. Who May Side With Mr. Towbin As Have Mayor Goodman, The City & All Agencies That Have Willfully & Negligently Failed To Identify, Report or Act On Mr. Towbin's Crimes."

I also demand that these same City or State agents make a public commitment to Gather and Review All Available Evidence (Documents, Videos, etc.) for review, for the purpose of being presented to the Attorney General, FBI and A Grand Jury.

B) This day December 11, 2007 I demand that Trisha Kean (and Contact 13 News) And Glenn Puit (and LV Review Journal) do Broadcast and or Publish the documents and Video Evidence Of The Above Crimes (Seen @ ChopperCarsFraud.com by over 200,000 viewers or hits and on YouTube.com by over 146,000 viewers under my user name: ERREEDOM). I have received many death threats as many viewers state: "You're just another worthless nigger & Negro looking to get something for nothing from the white man." Failure to do so may result in further liability, Negligence and a one billion dollar lawsuit. Based on Plagiarism (Contact 13 & Dateline "Tricks Of The Trade"), Malicious And Selective Reporting or Failure To Report Escalating & Violent Video Taped Crimes: Hate Crimes, KKK Like

Intimidation, Violations Of Free Speech And Civil Rights. You May Also Be Guilty Of Coercion or Conspiracy. By Having Knowledge of Towbin's Criminal History And Having Written Stories Thereof. It would seem Conspiratorial, Malisous & Prejudice for both TV & Print Media to Ignore The Most Well Documented And Confirmed Cases Of Systematic Acts Of Fraud, Lies, Deceit, Intimidation, Racial Slurs, Assaults, Hate Crimes, Retaliation, Civil Rights And Constitutional Rights Violations & Racketeering. By possibly The Independently Richest And Most Corrupt Automotive Dealership In The United States. "Topping All Tricks Of The Trade."

Please note: I did not call Towbin's Employee a Nigga or Nigger (In my Video Clips). I said "You are persuading me that you possibly could be a Nigga" (Which is simply the Black Hearted Evil Person that towbin & staff made me out to be each time they attached me, framed me or falsely called the police on me). Based on his anger, profanities, threats to frame & illegally handcuff me and his potential to harm me. After Towbin's employee did the above criminal acts I said "Now we know who the Nigga is around here."

It should be noted that Kean & Puitt rejected my story while Auto Dealer Complaints Were the #1 Consumer Complaint In America (USA Today Nov. 2003).

- C) Please be informed that I was diagnosed with Depression and a Bipolar Disorder In or about the year of 1985. That was believed by my doctor to have been Triggered by a very traumatic event that resulted in Extreme Weight Lost and Sleeping Disorders also. As a result of eating and discovering whole rodent parts In my Mc Donald's Apple pie in Hollywood California in around 1985. The forearm and rodent claws were embedded into the crust of the pie.

I may currently be experiencing serious depression and other conditions that prevents me from thinking, focusing thoughts, sleeping properly and other conditions. I tried to commit myself to the mental hospital in or around 2003. But became very afraid when they discouraged me from associating my problems (financial and otherwise) with fraud, lies, deceit and other criminal acts of Dan and Josh Towbin's Auto Dealerships.

However, I'm not violent like Mental patients Who Took Hostages at Mrs. Clintons Campaign Headquarters or like the Mall Shooter. I'm the only one being hurt in this case, by towbin and The State. "See my videos, only I show Love and speaking of Love."

I also suffer from bad intestinal bleeding, nearly constant tooth pain (etc.). As a Result of losing \$26,000.00 Cash, My Medical Coverage, Dental Coverage And much more to Towbin Fraud. I have informed city officials of these fact But they reject me at every turn, as have Senators John Ensign & Harry Reid. Towbin related loses have caused me to be Unable To Afford An Attorney and no Attorney has been willing to take my case or cases without a \$5,000.00 upfront payment.

I Therefore, demand that Senators Randolph Townsend, John Ensign & Harry Reid Look into these matters and arrange for Senate or Congressional Hearings on These injustices (Hate Crimes, Civil Rights & Constitutional Rights Violations, etc.).

Therefore, this day December 11, 2007 I demand that the state immediately provide me with Doctors and Lawyers that are of the State or that are paid for Via Contracts with the State.

- D) This day December 12, 2007 I Plead that the Honorable Governor Jim Gibbons will stop My Constitutional Rights (Civil Rights, Free Speech Rights, Due Process Rights, Equal Protection Of The Law Rights & Right To Report Violent Crimes Committed Against Me) From being Violated** By Towbin Automotive Enterprises and The City Of Las Vegas and or State Of Nevada.

I have Real Video Evidence Of Real Crimes that includes Systematic Assaults, Violent Intimidation, Racial Slurs Back With Violent Acts & Threats To Harm or Frame or File False Police Reports or False police Calls and Retaliation (etc.). By the Towbins and or their Staff.

Please make sure that my evidence is presented to a Grand Jury and to the FBI. Also make sure that the City Of Las Vegas or the State Of Nevada Does Hold An Immediate News conference. For the purpose of Denouncing All Hate Crimes & General Crimes Committed Against me and to make select Video Tapes & Documents available to the media. As I do fear for my life, based on Towbin's Violent Acts, Hate mail from YouTube.com Viewers & from Viewers at ChopperCarsfraud.com.

I plead that you also Grant Me A Pardon on the \$10,000.00 to \$20,000.00 that I now owe the internal Revenue Service. The above Mental, Physical & Financial Condition, as well as my Criminal and Constitutional Injustices have Crippled My Ability to reorganize or manage my life, finances and affairs.

Please help me to get Medical and Legal help also. I was diagnosed with a Bipolar Disorder by a Doctor in Visalia California. The attorneys who handled the Mc Donalds Rodent In Apple Pie Case were Arnald Abrams & Mary Anne Den Bok of Beverly Hills California. My records were lost as I systematically became homeless over the years.

- E) This day December 11, 2007 I Offer A Last Opportunity for Mr. Dan Towbin and Josh Towbin to Settle This Matter Before Putting It Into The Hands Of The Attorney General, FBI and or A Grand Jury.** For the purpose Investigating and or Prosecuting For Systematic Hate Crimes, Violent Intimidation, Retaliation, Assaults, Civil Rights Violations, Constitutional Violations and Racketeering.

The Cities Failure To Prosecute You For Initial Crimes Did Clearly Enable You To Overcome The 2 to 3 Year Statute Of Limitations. But Your Ongoing Criminal Activities And Penalties Related Thereto Are Criminally & Civilly More Damming To Your Person & Business. But These Are The Only Laws That Now Protect Me.

"All Manufacturers Who Supply Any Towbin Dealership With Vehicles Or Who Has Contracts With Towbin Will Be Notified Of Towbin's Criminal Act. E.R. Reedom Will Respectfully And Justifiably Ask That They Terminate All General And Exclusive dealership Contracts With The Towbin. Based on Systematic Criminal Activities and Lack Of Moral Turpitude by Dan towbin, Josh Towbin and the Entire Towbin Automotive Enterprises."

This Settlement Offer That I Now Make To You (The Towbins) Is Also Extended to The State (Metro Police, City Council, District Attorney, Attorney General, etc.). It Is Not Extortion, It Is Merely The Resolve And Peace I've Been Pleading For Over the Last Seven Years Or So. Please, Give It To Me, I Plead To One And I Plead To All. God Bless, Merry Christmas To All And To All A Happy New Year, By Gods Grace.

- 1. As Resent as April 26, 2006, Dan Towbin and Josh Towbin and or their employee's have engaged in KKK like Acts Of Intimidation, Threats To Harm Me and to Frame Criminal Acts on me, and Racial Slurs ("YOU FUCKING KIKE) & Hate Crimes Backed with Violence and actual assaults. At Towbin Dodge Super Store In Henderson.**
2. Likewise, a second assault occurred on or around April 10, 2006 after Making a Hateful and Angry Statement ("YOU'RE FUCKING WITH MY FAMILY") then hurting my right hand as he grabbed at my video camera. These violent acts seemed to be in retaliation to my protest to numerous other criminal acts. Including at least two acts of fraud, two acts of illegal "YO-YO Sales", at least 15 to 20 false police calls and 1 or more acts of false advertising.
3. Systematic Criminal & Unethical acts of Fraud, Lies, Deceit, False Advertising and False Police Calls initially occurred between May of 2000 and July of 2001. Evidence that both Credit Applications for two vehicle purchased within that nine month period of time had been Falsified. Was discovered on or around July of 2002.

More aggressive systematic acts of Defamation, Humiliation, Intimidation and more False Police Calls were directed towards me from on or around June 2003

through December of 2005. Which is when I begin to Protest at the old Jeep or Hummer Store on West Sahara Avenue.

However, on or around August 1, 2001 Towbin Automotive Enterprises did Maliciously try to get me fired by falsely stating to my employer that "I Derogatorily Called A Towbin Manager a Nigga."

4. **As of June 6, 2006, police officers at their downtown Metro Station. Refused to allow me to file a police report** that would have included both assaults plus important video evidence of these and other Towbin Crimes. Which are now posted on my website (ChopperCarsFraud.com) to help prevent me from getting Killed, Harmed or from losing important evidence. For this effort, those officers forced me to leave the property and immediately called police on me. This caused me to miss an assault hearing as I was, frightened, depressed and reluctant to open anything with the state seal on it. Most of the time asking for my support or money. I opened one letter on day of a hearing or sentencing and discovered that the case had been plea bargained and likely sealed.

District Attorney David Roger, Metro Police, Consumer Affairs, Better Business Bureau, Metro Fraud, Attorney General & DMV in my opinion have clearly Violated My Due Process Of Law Rights, My Civil Rights and My Constitutional Rights. They have also put my life in danger. By denying my right to file or report violent crimes. By preventing my claims and evidence from going before a Grand Jury. By failing to identify felony crimes (Fraud, YO-YO Sales, False Advertising, Hate Crimes, Intimidation, Wire Fraud, Racketeering, Conspiracy, etc.). By not enforcing existing laws against Fraud, Assaults, Hate Crimes, Violent KKK like Intimidation, False Police Calls or Reports and by not linking these crimes which are clearly Systematic Racketeering Crimes (By Law & Nature). By turning these types of serious felony crimes over to the DMV rather than to the DA. "If they turned OJ Simpson's Case over to the DMV, he would never be convicted."

As of January 2005 through August 1, 2007 Mayor Goodman and All City Council Members have ignored my claims and evidence of Systematic and Violent Crime By Towbin Automotive Enterprises and of serious, painful and or deadly illnesses That are caused by or Worsened by or Untreated Because Of The Effects Of Towbin's Criminal Acts. Who is now under their jurisdiction. Yet on August 1, 2007 After putting Towbin's Character Witnesses & Statements On Public Record (Including: Senator Townsend and High Ranking Military Officials). **The City Council Moved To Have My Evidence and Character Testimony of Dan Towbin Removed From City Records.** They may also have allowed an Intimidating Number Of Police To Be Present Because Of Me. They also Yelled At Me, Stopped My Speech With Hate & Anger and Treated Me Differently From Everyone else. This may be further Abuse Of Power By The State (Violation Of The KKK Act Of 1871).

The above parties are highly educated. I'm (E.R. Reedom) the Uneducated Fool. Therefore, I claim that all parties above did conspire to hinder my Civil Rights, Constitutional Rights and my Due Process Of Law Rights. In order to protect The Towbins From Metro Police, District Attorney, Grand Jury and From Laws Designed To Fine, Punish, Imprison and Close Such Criminal Oriented Businesses and Individuals.

5. **As of June 2002 I first went to Trisha Kean of Contact 13 with all my evidence on the Towbins. As I became homeless, divorced and unemployed She later closed my file and refused to expose the Towbins.**

As of May 2006 I hand delivered exclusive video to Contact 13 of Towbin or Staff Assaulting me, Making Racial Slurs and engaging in actual Hate Crimes Backed With Violence And Intimidation. Miss Kean again refused to expose Towbins Crimes. "It is my claim that Trisha Kean has Conspired To Protect the Towbins and has put my life in further danger and have emboldened my enemies."

6. **As of May 2006 I hand delivered exclusive video to Glenn Puit of Towbin or Staff Assaulting me, Making Racial Slurs and engaging in actual Hate Crimes Backed With Violence And Intimidation.** Mr. Puit of The Las Vegas Review Journal also refused to expose the Crimes And Violent Acts Committed Against Me by the Towbins and or their Staff. "It is my claim that Glenn Puit has Conspired To Protect the Towbins and has put my life in further danger and have emboldened my enemies."

7. **As of January 1, 2000 the El Cortez Casino was Caught On Video Cheating me out of Over \$400.00 dollars as confirmed by the Gaming Commission. They humiliated me with insults, defamation, rudeness (etc.) that contributed to my loss of over \$1,500.00 that day.** Yet Gaming failed to investigate and provide a report that would have produced like video evidence of The Plaza Casino Failing to pay a like bet and defaming and humiliating me equally as bad.

Likewise, they failed to present these criminal act to the District Attorney For Prosecution. They knew that two such criminal acts could establish a case for Racketeering. So they protected them by becoming Judge, Jury & Executioner, Saying it must have been a miscommunication, though I told them otherwise.

Currently I have a pending case against the Four Queen's casino for doing Basically the same Criminal act of cheating accompanied by insults and humiliation. As confirmed by agent Penn Of Gaming. Why, they seem to hate the fact that a \$2 to \$5 horn bet can generate or pay over \$400.00 to \$500.00 dollars if parlayed two to three times, as I often do. They seem to fear that other players would have every single number covered if they followed my lead. So they defame, humiliate and cheat me so badly that most players are not likely to make similar bets. It's like having a Slot Machine that Cheats You, Insults You, Defames You and Discourages You From Making Winning or High Return Bets.

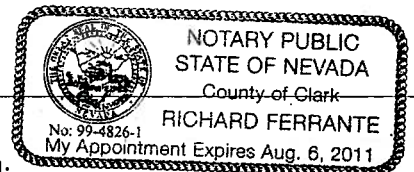
