**Cancellation Policy**

Exhibitors and dealers may cancel their show participation up to 7 calendar days prior to the event. Any payments for table fees will be refunded in full. Within 7 days of the event, exhibitors and dealers may cancel their participation and if any payment was made a full refund will be granted only if the tables cancelled are able to be resold to another exhibitor or dealer. A dealer who requests to pay their table fees at the event and subsequently cancels within 7 days of the event will be expected to pay for their tables if they cannot be resold. In this instance dealers will not be allowed to participate in any future Division 7 show until their account is made current. Any dealer who requests to pay their table fees at the event and subsequently fails to attend the event without notification will be removed from the Division 7 mailing list. Any dealer removed from the mailing list for this reason will be required to pay all fees owed before they will be permitted to participate in any Division 7 event and no future payment considerations will be made. Extreme circumstances may arise where an exhibitor or dealer cannot attend the event. This may include sickness, accidents or family emergencies. The Annual Swap Meet and Flea Market Chairman may make an exception and grant a refund of any fees paid.
