- Miss (18 years to 22 years) – Entry Fee \$55.00
- Teen Miss – (14 years to 17 years) – Entry Fee \$55.00
- Pre-Teen Miss (10 years to 13 years) – Entry Fee \$30.00
- Young Miss (7 years to 9 years) – Entry Fee \$30.00
- Tiny Miss (4 years to 6 years) – Entry Fee \$30.00
- Little Miss (25 Months- 3 Years)- Entry Fee \$30.00
- Baby Miss (14 months to 24 months) – Entry Fee \$30.00
- Wee Baby Miss (0-13 months) – Entry Fee \$30.00

Important Information

Teen Miss and Miss Contestants will compete in an Interview, Personality Wear and Gown categories. They will also participate in an opening number, which will not be judged. Gowns should be long and age appropriate. Personality Wear should be **non- glitz** and represent the individuality of the contestant. For the Interview, contestants may wear a dress or business/interview suit. Any wardrobe questions should be directed to the Pageant Director. Miss contestants will have a six (6) minute interview. Teen Contestant will have a five (5) minute interview. Miss contestant will be required to speak about community serves or a platform of her choice during personality wear; the speech will be thirty (30) seconds and timed. Points will be deducted if over the time limit

Pre-Teen, Young Miss, Tiny Miss, Little Miss, Baby Miss, Wee Baby Miss will compete in personality wear. **NO PAGEANT ATTIRE.** Contestants should have minimal make-up and outfits should be “off the rack.” For example, Pants/skirts, capris, dresses, etc. Contestants will not have points deducted if a parent escorts them on stage.

There is a non-refundable registration fee of \$30.00 for all age groups except Teen Miss and Miss, which will be a \$55.00 registration fee. Make checks payable to the Stafford County Fair. Pageant will be held rain or shine!

Rules and Regulations – All Contestants

1. Contestants must be single, never married, without children and never have been pregnant. Contestants must be female and have been born female, must possess good moral character having never been convicted of a crime nor have any criminal charges pending, and must have never committed an act or engaged in any activity which could be characterized as dishonest, immoral, immodest or indecent. Misrepresentation of any of the above mentioned will constitute intentional deception and will result in disqualification from the contest at the time of the competition or should this be the winner of any of the age divisions, forfeiture of the title to the 1st runner up will be enforced.
2. Contestant must currently live and or parents have a permanent address in Stafford County or any of the surrounding counties.
3. Contestants and guests will conduct themselves in a proper manner at all-times. Any display or poor sportsmanship or uncooperative behavior from the contestant or accompanying family/guest will result in disqualification from the contest.
4. Miss and Teen Queens will be required to participate in a few Stafford County Fair events. First, **must** participate in the Fair events scheduled October 17 – 20, 2019, Spotsylvania County Christmas Parade, Fredericksburg City Christmas Parade and Stafford County Christmas Parade, (December-Date TBD). You will be expected at the Stafford County First Night Out (Date – TBD). All Queens in all age divisions are welcome and encouraged to ride on the Stafford County Fair float at the Christmas Parades.
5. The winner of the Miss Stafford County Fair title may advance to the Virginia Association of Fairs State Pageant. This advancement is contingent upon having at least 5 Miss contestants vying for the Miss Stafford County Fair title, if there are less than 5 contestants the winner of the Miss Stafford County Fair title may choose to advance and compete in the Virginia Association of Fairs State pageant at their own expense, fees include competition registration, and accommodation expenses. Please remember that this commitment will require extensive preparation. We will assist you in every aspect of the competition but you **MUST** be willing and available. Failure to comply will result in forfeiture of the title to the 1st Runner Up. Failure to attend and participate in 3 scheduled practices, events, or meetings can result in forfeiture of title at the Director’s discretion.
6. Miss contestants will have a six (6) minute interview. Teen Miss Contestant will have a five (5) minute interview. The Miss contestant will be required to speak about community serves or a platform of her choice during personality wear; the speech will be thirty (30) seconds and timed. Points will be deducted if over the time limit.
7. Queens representing the Stafford County Fair are expected to conduct themselves in a mannerly fashion, including online activity. Facebook, Twitter, Snapchat, Instagram and/or similar sites need to be tasteful. Any infraction of this rule will result in one (1) warning. Any further infractions will result in immediate forfeiture of the title.
