Diann,

MCL211.24F requires that millage questions must include:

- The rate to be authorized
- b. The estimated amount of revenue that will be collected in the first year that the millage is authorized an levied
- The duration of the millage in years
- A clear statement of the purpose for the millage
- e. A clear statement indicating whether the proposed millage is a renewal of a previously authorized millage or the authorization of a new additional millage (an increase)

The ballot must disclose each local unit of government to the revenue from the millage will be disbursed.

So:

Shall the Township of Blissfield, County of Lenawee, State of Michigan impose an increase of up to 1.000 mills (\$1.00 per \$1,000 of taxable value) in the tax limitation imposed under Article IX, Section 6 of the Michigan Constitution and levy it for 6 years, 2022 through 2027 inclusive for general operations, daytime staffing and special equipment truck purchases, raising for the first year authorized and levied an estimated \$141,118.00 which shall be disbursed to the Blissfield Township Fire Department

As I understand it the current millage authorized in 2019 runs through 2022 therefore this request overlaps that millage and is therefore an increase. I am a bit leary of including three stated purposes but because they are all for the fire department I believe they are sufficiently tied to together so as to avoid any confusion. Is the rate correct?

# BLISSFIELD TOWNSHIP BALLOT MILLAGE FOR AUGUST 2, 2022 ELECTION

### **PROPOSAL A**

### **ROAD RENEWAL**

Shall the Township of Blissfield, County of Lenawee, State of Michigan impose and restore by renewal 1.4737 mills (\$ 1.4737 per \$1,000 of taxable value) to the limitation under Article IX, Section 6 of the Michigan Constitution and levy it for 4 years, 2023 through 2026 inclusive for road maintenance and improvement, raising for the first year authorized and levied an estimated \$207,966 which shall be disbursed to the Blissfield Township Road Fund.

### PROPOSAL B

### FIRE OPERATIONS RENEWAL

Shall the Township of Blissfield, County of Lenawee, State of Michigan impose and restore by renewal .9825 mills (\$.9825 per \$1,000 of taxable value) to the limitation under Article IX. Section 6 of the Michigan Constitution and levy it for 4 years, 2023 through 2026 inclusive for fire operations, raising for the first year authorized and levied and estimate \$138,649 which shall be disbursed to the Blissfield Township Fire Department.

### **PROPOSAL C**

### FIRE OPERATIONS RENEWAL

Shall the Township of Blissfield, County of Lenawee, State of Michigan impose and restore by renewal .0175 mills (\$.0175 per \$1,000 of taxable value) to the tax limitation imposed under Article IX, Section 6 of the Michigan Constitution and levy it for 4 years, 2023 through 2026 inclusive for fire operations raising for the first year authorized and levied an estimated \$ 2469 which shall be disbursed to the Blissfield Township Fire Department.

## **PROPOSAL D**

# FIRE EQUIPMENT RENEWAL

Shall the Township of Blissfield, County of Lenawee, State of Michigan impose and restore .5000muills (\$.5000 per \$1,000 of taxable value) to the tax limitation imposed under Article IX, Section 6 of the Michigan Constitution and levy it for 4 years, 2023 through 2026 inclusive for the purpose of acquiring fire equipment, raising for the first year authorized and levied an estimated \$70,559 which shall be disbursed to the Blissfield Township Fire Department.

### **PROPOSAL E**

NEW GENERAL OPERATIONS, DAYTIME STAFFING, SPECIAL EQUIPMENT TRUCK PURCHASES

Shall the Township of Blissfield, County of Lenawee, State of Michigan impose an increase of up to 1.000 mills (\$1.00 per \$1000 of taxable value) in the tax limitation imposed under Article IX, Section 6 of the Michigan Constitution and levy it for 6 years, 2022 through 2027 inclusive for general operations, daytime staffing, and special equipment truck purchases, raising for the first year authorized and levied an estimated \$141,118.00 which shall be disbursed to the Blissfield Township Fire Department.
