Searching for Stars: Official Rules

- 1. Eligibility 1.1. The competition is open to legal residents of the United States. The minimum age to participate in the Searching for Stars competition is 13 years old. For participants under the age of 18, it is mandatory to obtain permission and written consent from a parent or guardian in order to take part in the competition. Detailed instructions on how to digitally share the required consent will be provided to all eligible participants.
- 1.2. Employees, contractors, and immediate family members of Revohloo and its affiliates are not eligible to participate. in the competition.
- 1.3. Participants must provide accurate and truthful information during the registration process. Any false or misleading information may result in disqualification.
- 1.4. Participants are responsible for ensuring that their participation in the competition complies with all applicable laws and regulations.
- 1.5. Revolloo reserves the right to verify the eligibility of participants and to disqualify any individual who does not meet the eligibility criteria or fails to comply with the competition rules.

2. Overview

- 2.1. The competition will span over a period of 10 weeks, during which 200 contestants will battle for a chance to make it into the semifinals.
- 2.2. At the end of the 10 weeks, the top 20 contestants will advance to the semifinals, which will consist of 2 separate rounds.
- 2.3. Following the semifinals, the top 10 contestants will secure a spot in the finals, which will be a single round held LIVE and IN PERSON in Las Vegas.

3. Competition Entry Guidelines

- 3.1. To ensure compliance with copyright laws, all performances must be original, and contestants are required to have complete ownership of the rights to all content and music performed throughout the duration of the competition.
- 3.2. Entries are open to all music artists and genres: R&B, Rap, Hip Hop, Pop, Country etc. Contestants need only to showcase their unique talents, impress the judges/fans, and be ready to shine on the stage.
- 3.3. All entries and subsequent performances must adhere to community guidelines and avoid offensive content. Failure to comply will result in disqualification from the competition and the forfeit of paid entry fee.
- 3.4. All paid entry fees are final. There will be NO REFUNDS.

4. Competition Phases

- 4.1. Weeks 1-10 (Preliminaries) will feature weekly battles where contestants will compete showcasing their talents and skills to determine the top 20 contestants who will advance to the semifinal rounds.
- 4.2. Weeks 11-12 (Semifinals) will feature the top 20 contestants from the previous 10 rounds competing fiercely for a coveted spot in the Final Round of the competition.
- 4.3. Week 13 (Finals) will culminate with a final performance showdown where the 10 finalists will

5. Voting Process

- 5.1. Fans will vote for their favorite contestants through the Revohloo platform.
- 5.2. Each fan is allowed to cast one vote per contestant each day.
- 5.3. Judges/Free votes and paid votes

6. Advancement Criteria:

- 6.1. Votes that are cast each week will determine which contestants will move on in the competition. To advance, contestants will need to receive enough votes to proceed to the next round.
- 6.2. The number of artists advancing each week will be announced at the beginning of the competition.

7. Prizes

- 7.1. The cash prize pool will be shared among ALL the 10 finalists. That's right, ALL FINALISTS will receive a CASH PRIZE!!
- 7.2. The prize amount awarded to each finalist will be determined by their final performance ranking in the competition. The higher an artist places, the higher the cash prize!!
- 7.3. The top 3 ranking finalists will be rewarded with an EXCLUSIVE opportunity to host their own Pay-Per-View special, which will be aired across Revohloo's Roku and Amazon Fire TV channels! These lucky winners will not only have a chance to promote their own Pay-Per-View special, but they will also share in the revenue that is generated. And rest assured that the artists will receive the lion's share of the revenue generated from the event. Additionally, Revohloo will go the extra mile by promoting the artist's PPV specials across all our social media platforms, including paid promotion to assist with ensuring maximum exposure of the events.

7.4. Studio Time

Please note that cash prizes awarded to the winners may be subject to federal, in-state, or local taxes. Winners will be solely responsible for reporting and paying any applicable taxes associated with prizes. We recommend consulting with a tax advisor or professional to understand the tax implications and obligations related to accepting any cash prizes.

- 8. Judging and Final Performance 8.1. The final round performances will be judged by a panel of industry judges and fans.
- 8.2. The combination of judges' scores and fan votes will determine all prizes awarded at the end of the competition.

9. General

- 9.1. By participating in the competition, contestants agree to abide by all official rules and decisions made by Revohloo.
- 9.2. Revolution reserves the right to disqualify any contestant for violating any of the contest rules, guidelines, or engaging in fraudulent/inappropriate behavior.
- 9.3. Revolloo is not responsible for technical issues or other factors that may affect the voting process.
- 9.4. Contestants grant Revohloo permission to use any entry content, as well as any content generated during the competition, for promotional, marketing, and other related purposes.

Failure to adhere to the rules and guidelines of the competition may result in disqualification. In such cases of disqualification, contestant's entry fees will not be refunded. It is essential that all contestants thoroughly review and follow all instructions and requirements outlined in the competition guidelines and rules.

10. Competition Modification

- 10.1. Revolution reserves the right to modify the competition rules, terms, and conditions at any time without prior notice.
